### **Civic Federation Candidate Night Forum**

The September 2 meeting, our annual Candidate Night Forum, is the start of the fall campaign season for those seeking public office in November. This is always one of the most popular meetings of the Civic Federation with a large number of nonmembers attending. It provides an opportunity for members of the Civic Federation to be able to interact with candidates Because of the stature of the Civic Federation, we always have excellent turnout from the candidates.

Although only delegates and alternates may ask questions, the public is invited to see how the candidates respond to often very pointed questions. Be sure to invite members of your association to join us.

### **Program Order**

The confirmed candidates for each race will appear as a group in the following order:

- County Board
- School Board
- Arlington County Treasurer
- U.S. Senate
- U.S. House of Representatives

#### **Questions**

Audience questions from Civic Federation delegates and alternate delegates will be entertained through a drawing system.

Civic Federation delegates and alternate delegates may register to have their name drawn by signing up in the lobby at 7:00 p.m. Delegates and alternate delegates may register to ask a question for multiple panels.

In order for more delegates and alternate delegates to have an opportunity to ask a question, the forum moderator will give first priority to delegates and alternate delegates who have not yet had a turn. The forum moderator will draw a delegate or alternate delegate name and then call on them to ask their question.

Questions may be directed to one or more candidates. **Questions** may be no longer than thirty seconds and may not be position statements. Follow-up questions are not allowed. The Civic Federation's rules will be observed at all times.

### **Permit Requirements for Public Spaces**

At its 7/19/14 meeting, the Arlington County Board approved revisions to the county's Policy for Managing Special Events and Demonstrations in Public Spaces. These changes were prompted by the increase in pub crawls and the sometimes raucous behavior of their participants in public.

The new policy replaces the original 2012 version. In addition to redefining the meaning of "special event," the policy also notes that the county will charge special-event organizers for "personnel and services on a 100% cost-recovery basis unless prohibited by law." Permits must be obtained for ALL special events and demonstrations.

ACCF member organizations should also be aware that the term "demonstration" applies not only to protests but also to other gatherings, including vigils or religious services, in public areas:

The term "Demonstration" shall mean any picketing, speech making, marching, holding vigils or religious services and other like forms of conduct, in Public Spaces, which involves the communication or expression of views or grievances, is engaged in by one or more persons, and has the effect, intent or propensity to attract a crowd or onlookers." The term "Demonstration" shall not include the casual use of Public Spaces by Arlington County residents or visitors which use does not have the effect, intent, or propensity to attract a crowd or onlookers.

Therefore individual citizens or groups are prohibited from gathering or otherwise exercising first-amendment rights in public spaces without first obtaining the required permit.

#### **Videotaping of Federation Meetings**

Arlington Independent Media did a great job last March filming the County Board Candidates forum. I would like to again thank them, as they did this pro bono for the Federation.

In the past, the Federation Executive Committee noted some attendees filming via cell phone. Audio or video recording requires prior approval of the President or delegated Chair of the event per Federation policy. Any individuals not in compliance will be asked to leave the meeting.

### Draft Parkland Preservation Resolution Consideration at the October Meeting

WHEREAS, current County planning processes, including Capital Improvement Plans and "Public Land for Public Good," propose to use current or intended publicly-owned park, open space, or recreation/community facility sites for other purposes, such as housing and schools; NOW

THEREFORE, BE IT RESOLVED, THAT Arlington County Civic Federation urges that no current or intended publicly-owned park, open space or recreation/community facility sites be utilized for any purpose other than park, open space or recreation/community facilities, now or in the future; and Arlington County Civic Federation urges Arlington County Board and Arlington School Board to cease any further actions in regard to selecting, planning, or otherwise using any current or intended publicly-owned park, open space or recreation/community facility sites for other purposes, such as housing or schools.

## **Casting Votes on ACCF Resolutions Consideration at the October Meeting**

At the October 9, 2014, ACCF meeting, Federation delegates will consider and vote on Delegate Kathryn Scruggs' proposed amendment to add the following language to Article III, Section 5 of the ACCF By-laws:

A member may vote on behalf of each organization for which the member is listed as a delegate or alternate.

The full text of Ms. Scruggs' proposed amendment, which she submitted at the June 3, 2014, Federation meeting reads:

Whereas, there is discussion about the number of votes a delegate who represents more than one member organization may cast.

Whereas the By-laws state in Article III, Members:

Section 5. Each member organization shall be entitled to no more than four (4) votes cast by the delegates or their alternates. No

proxy votes may be cast.

Whereas the By-laws state in Article IX, Amendment to the By-laws:

These by-laws may be amended at any regular meeting of the Federation by a two-thirds vote, provided that the amendment has been submitted in writing at the previous regular meeting.

I move that the By-laws be amended to state, specifically, that a member may vote on behalf of each organization for which the member is listed as a delegate or alternate and, until the vote on amending the By-laws, the Chair will rule on the number of votes permitted members who represent more than one organization.

Article IX of the ACCF By-laws specifies that the Federation may amend the By-laws "at any regular Federation meeting by a two-third vote, provided that the amendment has been submitted in writing at the previous regular meeting."

President Michael McMenamin referred Ms. Scruggs' proposed amendment to the By-laws Committee, which will post its report on the proposed amendment on the Federation website and in the October "The Civic Voice."
