Therefore, be it resolved that the Arlington County Civic Federation urges the County, as part of the Community Energy and Sustainability (CES) effort, to examine the feasibility of accelerating conversion of Arlington's street lights to LED units. This process could concentrate first on street lights owned by the County, followed by conversion of those owned by Dominion Virginia Power. The goal would be to convert all Arlington street lights as soon as possible.

**Secretary's Report** - (Minutes from June 1, 2010 Civic Federation membership meeting):

The meeting called to order at 7:30 pm by Mike Kerley, President. The Pledge of Allegiance was led by Randy Swart from the Barcroft School and Civic League. Opening the meeting, the agenda was approved as submitted; minutes for the May 4, 2010, membership meeting were distributed and approved; the treasurer's report was approved.

The Nominating Committee, elected at the April 6 meeting, introduced the following slate of officers for 2010-2011: Mike Kerley, President; Terri Prell, Vice President; Peter Olivere, Secretary; Eileen Williams, Treasurer. The proposed Executive Committee slate was Mark Antell, Gary Barbee, Burt Bostwick, Larry Finch, Amy Levin. The complete slate was unanimously approved.

Jay Fisette, Chair of the Arlington County Board, introduced the new County Manager, Michael Brown. Mr. Brown made brief remarks addressing themes requested by the Executive Committee.

The County's proposed Capital Improvement Program (CIP) was addressed by a panel: Michelle Cowan, Arlington County Assistant Chief Financial Officer; Mary Beth Chambers, APS Assistant Superintendent of Finance and Management Services; Bill O'Connor, APS Director, Design and Construction Services. In unfinished business, a motion from the Bylaws Committee proposed to amend Article VII Section 3 of its Bylaws to read: Committee recommendations to the Civic Federation are valid after an announced meeting is held by the committee and a vote on the recommendation is recorded. Committee reports shall be in writing. A copy of the report shall be given to the president and to the secretary. After discussion, a subsidiary motion (Peter Owen; Robert Atkins) to refer back to committee passed 37 yes and 4 no.

In new business, Joe Pelton (seconded by Sharon Jolly) introduced a resolution on the County's use of LED street lighting. The resolution was subsequently transmitted to the Public Services Committee.

The meeting adjourned at 9:45 p.m. until the next membership meeting on September 7, 2010.

- 1. This document details the rules for the Arlington County Civic Federation candidate night forum that will be held on Tuesday, September 7, 2010, at 7:30 p.m. at the Hazel Auditorium, Virginia Hospital Center, 1701 North George Mason Drive, Arlington, Virginia.
- 2. Candidates running in the November 2, 2010, general election for the following offices are eligible to participate in the forum:
  - Member, U.S. House of Representatives 8th District of Virginia
  - Member, Arlington, Virginia School Board
  - Member, Arlington, Virginia County Board
- 3. Each office will be a distinct panel of candidates.
- 4. When their panel is called, candidates will take their places at the table. Substitute speakers are not permitted. If a candidate does not participate, the panel will go on.
- 5. Candidates may make opening statements from the podium. Speaking order will be determined by a drawing at the start of each panel. Candidates will have an opportunity to field questions from the audience. Closing remarks will allowed for contested races. Candidates may use notes.
- 6. The candidate panels and time per panel will be organized as shown in the table below:

7. The order of answering questions will rotate. Candidates will be informed by cue card when time is short and has run out.

- 8. Audience questions from Civic Federation delegates and alternate delegates will be entertained through a drawing system.
- 9. Civic Federation delegates and alternate delegates may register to have their name drawn by signing up in the lobby at 7:00 p.m. Delegates and alternate delegates may register to ask a question for multiple panels. In order for more delegates and alternate delegates to have an opportunity to ask a question, the forum moderator will give first priority to delegates and alternate delegates who have not yet had a turn.
- 10. The forum moderator will draw a delegate or alternate delegate name and then call on them to ask their question. Questions may be directed to one or more candidates.
- 11.Questions may be up to thirty-seconds long and may not be position statements. Follow-up questions are not allowed.
- 12. The Civic Federation's rules will be observed at all times.
- 13. The forum is a nonpartisan event and takes place on the property of the Virginia Hospital Center. Customary rules apply. Cell phone use in patient care areas is restricted.
- 14.Literature may be distributed only in the conference center lobby from 7:00 P.M. until 9:30 p.m. Signs, banners, demonstrations and electronic presentations are not allowed on the property including outside the building and in the lobby, hallway, and auditorium.
