

Minutes - February 5, 2008 ACCF Membership Meeting

- 1. Meeting called to order at 7:30 pm by Larry Mayer, President. The Pledge of Allegiance was led by John Waters of the Lyon Park Civic Association.
- 2. Agenda approved as submitted.
- 3. <u>Approval of Minutes</u>. The minutes of the January 8, 2008 membership meeting were distributed and approved as submitted.
- 4. <u>Treasurer's Report</u>: The full report is available on Civic Federation website. Balance on hand is \$4,254.03. Seventy-three (90%) of the member organizations have paid their dues as of February 5, 2007.
- 5. Committee Reports and Announcements:
 - The Information Technology Advisory Commission did not hold hearings on January 16 and January 19 to accept testimony about Cavalier as a cable services provider. The South Arlington franchise agreement appears on the county website. Hearings will be rescheduled for a later date
 - The Towns of Courthouse Hill was unanimously accepted as a new member.

- 6. Special rules for this meeting with the County Board were announced as published in the newsletter, the agenda and on the website.
- 7. The annual meeting with County Board members (Jay Fisette could not attend) was conducted over an hour and 40 minutes primarily directed by questions from Civic Federation members. - 8. A resolution on Accessory Dwellings was presented jointly by two Civic Federation committees: Housing and Planning and Zoning. During the ensuing discussion the following actions were taken:
 - a. Time was extended 4 times for a total of 45 minutes.
 - b. The following motions were voted on (NOTE: Aurora Highlands Civic Association delegates abstained from all votes)
 - (1) Motion to call the question passed by over the required two-thirds of those voting.
 - (2) Motion to defer all action to June was defeated.
 - (3) Motion to defer for one month to the March meeting was defeated 32 to 26.
 - (4) Motion to amend the resolution to remove "supports amending the Zoning Ordinance" and substituting language only urging consideration of the issues outlined in the resolution was passed 47 to 12.
 - (5) The main motion on the resolution was then passed by a vote of 52 to 5.
