



## Update Lee Highway Re-Visioning

Sandi Chesrown will be providing us an update of the grassroots strategic partnership for re-visioning Lee Highway that is moving forward via 15 civic associations, including Waverly Hills, Arlington East Falls Church, John M. Langston, Glebewood, Yorktown, Tara Leeway, Leeway Overlee, Old Dominion, Donaldson Run, Cherrydale, Waycroft Woodlawn, Maywood, Rock Spring, North Highlands, and Lyon Village. The group is being assisted by Arlington County’s Planning Department and other County department staff.

During the educational phase, relevant topics - including land use planning and zoning, smart growth, urban design, housing, transportation and parking, signage, demographic trends, tax increment financing, transferable development rights, local business preservation, and new economic opportunities were presented and discussed.

The educational phase transitioned in the fall of 2014 into a community meeting phase, and the results of those meetings will be presented to the Federation. The County Board agreed in November to fund a planning and design charrette to be led by consultants in 2015, resulting in a joint community vision for a more economically vibrant, walk-able, attractive Lee Highway corridor – one that benefits neighborhoods and the business community and does not result in piecemeal development.

It is anticipated that the new vision will be sent – in 2015 - to the Arlington County Manager’s office and the County Board with a request that they appoint and staff a Task Force to formally develop either updates to the GLUP or a Lee Highway Sector Plan to guide future rezoning and development applications along Lee Highway.

## County Manager Program

The County Manager will give a 15 minute presentation based on the questions we sent from the Federation's Executive and at large Committees. Upon completion of the presentation, Federation delegates will ask questions of the County Manager for 15 minutes.

Delegates are reminded that questions may be up to 30 seconds in length and may not be position statements. No follow-up questions will be allowed. In the interest of time and fairness, member delegates may only ask 1 question. This is a 30 minute program.

Ms. Barbara Donnellan is County Manager of Arlington County, Virginia. Barbara Donnellan was named Arlington's County Manager in October, 2010, becoming the first woman named County Manager in Arlington. She began her career with the County in 1983.

Under Ms. Donnellan's leadership, Arlington County has successfully implemented nationally-recognized Smart Growth planning policies and continued the sound financial policies that have earned the County its triple-AAA bond rating for many years.

## School Superintendent Program

The Superintendent will give a 15 minute presentation based on questions submitted to him from the School's Committee. Upon completion of the presentation, Federation delegates will ask questions of the Superintendent for 15 minutes.

Delegates are reminded that questions may be up to 30 seconds in length and may not be position statements. No follow-up questions will be allowed. In the interest of time and fairness, member delegates may only ask 1 question. This is a 30 minute program.

Dr. Patrick K. Murphy has been Superintendent

of Schools since July 1, 2009. Dr. Murphy is an Arlington County resident and has been an educator since 1988, serving the Fairfax County Public Schools for 19 of the intervening years in a variety of instructional leadership positions. During the final four years, he served as assistant superintendent for accountability, where he was responsible for testing, research and evaluation, and division- and school-based strategic planning.
