Environmental Sustainability Profile Presentation

Representatives from the County's Office of Sustainability and Environmental Management will present June 7th on Environmental Sustainability in Arlington. The panel members are: Jeff Harn, Chief of the Office; Joan Kelsch, Green Buildings Program Manager; Richard Dooley, Community Energy Coordinator; Aileen Winqvist, Watershed Outreach Program Manager; Mary Strawn, Water Pollution Control Plant; and Shani Kruljac, Solid Waste Bureau.

The Panel will discuss challenges and progress in achieving environmental sustainability in the program areas of solid waste, storm water management, wastewater treatment, and energy conservation. Given Arlington's projected growth over the next 25 years (from 216,000 residents to more than 280,000), limited land area, and increasingly stringent regulations, environmental issues will continue to present major technical and budgetary challenges.

Arlington's solid waste initiatives promote sustainability in waste management through investments in waste-to-energy infrastructure, efficient recycling of many of Arlington's waste streams, and waste minimization. Stormwater compliance faces an aging infrastructure, increasing numbers of stormwater facilities from private development, severe and continuing erosion of local streams, and strengthened requirements for preservation of the Chesapeake Bay and local water quality standards. To reduce stormwater runoff and improve its quality, Arlington is continuing to invest heavily in storm water treatment measures through sewer system improvements, flood projects, stream restorations, and watershed retrofits, among other initiatives.

Energy conservation efforts are directed at mitigating the impacts of global climate change and reducing greenhouse gas emissions. Arlington's programs to promote energy conservation and reduce air pollution include investments to promote energy efficiencies in both residential and non-residential structures, renewable energy

sources, the expansion of Arlington's transportation infrastructure, and educating Arlington residents on ways to reduce energy usage.

Arlington County Blue Ribbon Panel: Request for Input by July 1

Various civic leaders received a letter from the Arlington County Board regarding the Blue Ribbon Panel on Strategic Priorities.

In order to guide the feedback, they provide specific questions, although other comments are welcome. The Board requests public comment at <http://commissions.arlingtonva.us/strategic-priorities-for-arlington-blue-ribbon-panel-charge/>. Comments should be received no later than July 1, 2016.

The questions are:

1. Which tasks described in the Charge cause concern to, or require further clarification for your Commission/organization? Are there any tasks with which you are already comfortable or supportive? Are there any tasks you would add?
2. What elements or questions would you recommend be incorporated in the Panel's report to the County Board? Are there other deliverables that you think the Panel should generate?
3. What additional guidance (not formally part of the Charge) would you like the Panel to consider? For example, what forms of engagement would you like Panel to pursue with your Commission? With the general public?

Accessory Dwelling Revisited

In 2008, the County Board voted to revise the Arlington County Zoning Ordinance to allow Accessory Dwellings ("ADs"), which are apartments on lots zoned for one family. The Board approved interior ADs in basements and in additions to the house, but rejected exterior ADs in standalone accessory buildings such as detached garages.

Since 2008, relatively few ADs have been added to Arlington's housing stock, mostly due to construction rules such as the 750 SQFT size limit and requirements for separate utilities.

Now there is a new impetus to build ADs, in part driven by the inclusion of ADs in the recently-adopted Affordable Housing Master Plan — and calls to loosen the rules for interior ADs. In addition, there is renewed interest in allowing exterior ADs.

In 2008, the ACCF captured neighborhood interest in allowing ADs via a survey completed by ACCF delegates and the public. The ACCF's Planning & Zoning Committee invites delegates and others to join a P&Z SubCommittee that will develop a 2016 Accessory Dwelling Survey, which will revisit the 2008 considerations and propose some new ideas. Survey work will begin this Summer in order to be completed in early Fall so it can be part of a Housing Division report.

Revenues & Expenditures Committee Resolution on General Fund Available Balances Allocations

The Revenues & Expenditures Committee Resolution received only minor adjustment before passing 22 to 13 on May 7. For the committee report and final resolution, refer to: <http://www.civfed.org/committees/revenues-and-expenditures/>

THEREFORE, be it resolved that the Arlington County Civic Federation urges the Arlington County Board to annually **CONSIDER SETTING** aside a fair and reasonable amount of any surplus for the reduction of real estate taxes. (Using the \$21.8 million FY2015 closeout balance as an example, an allotment of approximately \$7 million for tax relief would have allowed roughly a 1-cent reduction in the real estate tax rate.)

BE IT FURTHER RESOLVED the Arlington County Civic Federation urges that any apportionment of any annual available balance be subject to a transparent and robust public process, including written proposals by the County Manager sufficiently in advance of any final decision, one or more public hearings before the County Board and adequate opportunity for written comment, and final decision by the County Board at one of its monthly meetings.

Arlington During World War II: The Federation Comes to the Defense of Milk Consumers

In Arlington, people called it “the emergency.” America went to war in 1941, and until World War II ended four years later, daily life was transformed in ways large and small. Soldiers were called up and sent to the front lines. The economy was re-gearred to support the war effort. There was rationing and new security measures on the home front.

Every household in the county was touched. In some cases, families struggled. The armed forces needed the county’s able-bodied adults, some of whom perished during the conflict. In Arlington, the military bureaucracies at the Pentagon and the Army’s code-breaking facility at Arlington Hall drew in countless others. Often the economic constraints brought hardship. Cupboards were not so full; dinner tables bore simpler fare.

Authorities rationed many items, including dairy products such as butter, cheese and canned milk. This put pressures on both producers and consumers, and a dispute over the price of milk began to brew in 1942. Some producers wanted to raise prices. Consumers, feeling pinched as it was, had their concerns represented by the Federation.

The Virginia Milk Commission, which regulates the industry, held a hearing in Alexandria 1942 so that both sides could air their views. A representative for some local producers requested that milk prices be raised in order to shore up falling profits. He noted that the county’s population was 73,000, with average milk consumption at 1 pint per person per day. Even though demand for milk was rising, the representative said, production costs were also going up.

A number of people spoke in opposition to the price increase, including Mr. G. P. Sanders, representing the Federation. In a summary of the meeting, Sanders wrote that it was the Fed-

eration’s view that “any further increases in retail prices of milk at this time would be unjustified and would be harmful to the best interests and welfare of the public.”

The matter involved months of discussions, and another meeting of the commission was scheduled for January 8, 1943. At its January 5 meeting, federation members sensed the urgency of acting quickly in order that their views be presented at the upcoming commission meeting. Consequently, Federation members unanimously adopted a lengthy resolution outlining their opposition to the price increase. One reason was that a change “may curtail the consumption of milk by those who cannot afford higher prices and will contribute to inflation, thereby seriously affecting the war effort of the United States of America and her Allies.

The citizens of Arlington did more than their fair share to support the war effort. In order to represent the interests of the citizens, especially those in the most need, the Federation was a voice speaking energetically on their behalf during this great national emergency, at least when it came to the price of milk.

Four Mile Run Valley (4MRV)

Arlington County’s latest study area encompasses the Four Mile Run Valley (4MRV) with its wide-ranging uses via parks, commercial, and residential. The proposed study encompasses approximately 95 acres. Areas include range from heavy industrial, service commercial and public services to Jennie Dean Park, Nauck Town Square, and Shirlington Park, Shirlington Dog Park.
