

Minutes – September 6, 2016 ACCF Membership Meeting

Federation President Stefanie Pryor called the meeting to order at 7:01 PM in the Hazel Auditorium at the Virginia Hospital Center. President Pryor led the meeting in reciting the Pledge of Allegiance. The meeting's agenda and the June 7, 2016 Membership Meeting Minutes were approved as submitted.
