

Draft Minutes – October 4, 2016 ACCF Membership Meeting

Federation President Stefanie Pryor called the meeting to order at 7:00 PM in the Hazel Auditorium at the Virginia Hospital Center. President Pryor led the meeting in reciting the Pledge of Allegiance. The meeting's agenda and the September 6, 2016 Membership Meeting Minutes were approved as submitted.

Meeting Times: President Pryor reminded attendees that ACCF General Meetings now start at 7:00 PM. and Executive Committee Meetings at 6:30 PM.

Treasurer's Report: President Pryor announced on behalf of Treasurer Pat Spann that the Federation had balances of \$6,059.93 in its checking account and \$20,870.92 in its savings account as of 9-25-2016.

New Delegates and Alternates: President Pryor welcomed new delegate Gail Ginsburg of Dover-Crystal and David Bodner, a new alternate for Ashton Heights.

Career Center Video recording of this Meeting: President Pryor thanked Career Center students Rudy Henriquez, Daniela Londono and Christian Porter and their Career Center instructor Tom O'Day for making a video recording of this Federation meeting.

Membership Committee: President Pryor announced that the Membership Committee had referred boundary adjustments for the Douglas Park Civic Association to the Federation's Executive Committee, and ExComm had approved them at its July 10, 2016 meeting. Rick Epstein of Friends of Arlington Parks reminded the meeting that there were still unresolved boundary issues in the Four Mile area of South Arlington. President Pryor said boundary adjustments requested by the North Highlands Citizens Association were waiting for approval by neighboring civic associations.

Planning & Zoning: P&Z Chair Martha Moore reported that the County Board had put consideration of a Short-Term Residential Rental Ordinance on a fast track. She said the county manager would be discussing input from citizens at the County Board October 15th meeting. Ms. Moore said she needed help organizing an opinion poll on a county ordinance regulating "Airbnb" rentals. 2016 Arlington School Bond Referendum: Peter Fallon and Monique O'Grady introduced themselves as 2016 School Bond Co-Chairs and gave a presentation on the 2016 School Bond Referendum. Questions from delegates and alternates included the following: what would happen if the referendum did not pass? Was the increasing number of millennials affecting the percentage of voters in favor of school bond referenda? Given the comparatively cost of public school education in Arlington and the top-of-the-line schools on which this bond would be spent, where is the cost containment? Michael Beer of the ACCF Schools Committee warned that even with this bond, needed additional seats were unfunded. Lois Koontz, also of the ACCF Schools Committee, said that the public process contributed to the cost of new schools by increasing the amount time required to build them.

Urban Agriculture: Kimberly Haun of Arlington's Department of Parks and Recreation gave a presentation on the county urban agriculture program which supports a variety of educational programs on nutrition and traditional and nontraditional personal and community gardening; Arlington's eight farmers markets; the Virginia Farm to Table initiative; and the Arlington Food Assistance Center. A delegate asked how the urban agriculture program cost Arlington's taxpayers.

CivFed 911 Scholarships: ACCF 911 Committee Chair James Pebley gave a presentation on the history and purpose of the ACCF 911Scholarship Fund. He explained how scholarships were awarded and to whom they were awarded in 2016. He reviewed the financial status of the Fund and the need for contributions so that it could fulfill its mission.
