June Meeting: We have a packed agenda for our final meeting of the 2016-2017 year. First, we have elections of our 2017-2018 officers and Executive Committee. The Virginia Commonwealth legislative delegation presents an overview of their experiences in Richmond, followed by a question and answer period. We get to hear the lighting round of 1773 bills and resolutions, including the budget, and the 40 vetoes by Governor McAuliffe. Please join Senators [Janet Howell](#) (32nd District), [Adam Ebbin](#) (30th District) and [Barbara Favola](#) (31st District); and Delegates [Alfonso Lopez](#) (49th), [Rip Sullivan](#) (48th), and [Mark Levine](#) (45th). Unfortunately, Delegate [Patrick Hope](#) (47th) is out of the area, but many of you were able to speak to him at our recent banquet.

Our new Arlington County Internal Auditor, Dr. Chris Horton, and a member of the Army’s Inspector General’s staff, Chris Essig, provide explanation of their roles in good governance and oversight. Mr. Essig is a long-term resident of Penrose Neighborhood and Arlington County Emergency Preparedness Advisory Commission member.

We will discuss and vote on a revised insurance resolution. Although at times discouraging, but informative, the May panel presentation provided additional points and clarifications for the resolution.

May Meeting: The insurance discussion brought out many new audience members. We also received updates for the yard waste program and newly funded Complete Streets program. R&E Committee’s Retirement Plan Information resolution by a vote 26 to 2 with 3 abstentions. If you missed it in person, please check out the digital recording posted via Vimeo channel.

Arlington County Civic Federation Resolution Concerning Liability Insurance

Whereas, one of the pillars of citizen participation in Arlington County embodied in the “Arlington Way” is encouraging citizens to participate in their civic associations and other civic groups;

Whereas, the Arlington County Civic Federation, throughout its 101 years with its +/-80 member organizations, was formed to facilitate citizen participation in Arlington County;

Whereas, the vast majority of these member organizations are small, nonprofit organizations run by volunteers, with limited organizational structure and/or financial and human resources;

Whereas, Arlington County has considered modifying some county processes — for example, the Neighborhood Conservation Advisory Committee, which would require civic associations to assume responsibilities for certain NC functions including property owner notification, conducting and helping to design neighborhood surveys, maintaining records, etc. — thereby exposing civic associations, their officers and representatives to potential liability;

Whereas, the County specifically asks for the Civic Federation to solicit and provide input and feedback on county processes and policies, thereby increasing potential liability exposure to the Civic Federation, its officers, Executive Committee and member-organization delegates and alternates;

Whereas, in some instances the County may require nonprofits to obtain a Commercial General Liability Insurance policy for \$1 million “Per Occurrence” and \$2 million “Aggregate”;

Whereas, the current +/- \$1,500 cost of insurance premiums for civic associations to obtain Directors and Officers Insurance plus an umbrella Commercial General Liability Insurance policy of \$1 million far exceeds the financial ability of most ACCF member organizations;

Whereas, exposure to potential liability can deter citizens from actively participating in civic organizations and civic life;

Whereas, the County enjoys the financial and practical benefits of the time, effort and expense contributed by volunteers and volunteer organizations, including such efforts as invasive plant removal, Tree Stewards, library volunteers, assistance in the dissemination of community and public notices, environment cleanup events, County fair workers, Medical Reserve Corps, Community Emergency Response Team (CERT) members, etc.;

Therefore be it resolved, the Arlington County Civic Federation:

1. Asks Arlington County to reconsider requiring civic associations to have Commercial General Liability Insurance Coverage in order to use public property, which could discourage or restrict citizen participation;
2. Asks Arlington County to minimize factors that could increase exposure to civic association members, leaders and representatives in designing or revamping processes and policies that shift liability exposure from indemnified County staff to volunteers.
3. Asks the County to study alternatives to reduce liability and risk to civic organizations and their volunteer members, leadership and representatives when participating in or promoting civic activities.
4. Asks Arlington County to provide volunteer groups and individuals who are contributing their time and efforts for the benefit of the County with indemnification protection so long as those groups and individuals comply with rules established by County policies.

The Executive Committee prepared the resolution because most Arlington County Civic Federation member organizations have limited organizational structure and/or financial and human resources to pay for Commercial Liability Insurance and want to bring this to the attention of the County Board.

Peace Officer's Memorial

For the first time since the Police Memorial Statue was dedicated in 2005, a fallen Arlington County law enforcement officer's name will be added in remembrance. Corporal Harvey Snook passed away on January 14, 2016, as the result of cancer contracted while working in the recovery efforts at the Pentagon following the terrorist attack on September 11, 2001. Corporal Snook was a U.S. Army veteran and had served with the Arlington County Police Department for 27 years.

Year-Round Yard Waste Program

At the request of the Civic Federation (2015 Resolution), Erik Grabowski, Chief of the Solid Waste Bureau of the Department of Environmental Services, reported on the one-year anniversary of the new Year-Round Yard Waste Collection Program. That program, begun in April 2016, seeks to divert organic yard waste from incineration at the waste-to-energy facility and collect it for recycling and reuse. Mr. Grabowski reported that more than 90% of eligible households had elected to receive yard waste carts, indicating widespread participation in the program. The County estimates that, of 9,000 total tons of organic waste generated annually, nearly 7,200 tons had been collected for recycling during the first full year—nearly 5 times the volume collected during the prior seasonal organic waste collection process. Arlington's residential recycling rate has increased from 51% to 58% of total waste. Arlington is also beginning to mix its shredded organic waste to create topsoil for use at Arlington's parks. Mr. Grabowski expressed the Solid Waste Bureau's desire to extend the organic waste program to include food waste in future years, provided issues of capacity, cost, and infrastructure availability could first be resolved.
