Revenue & Expenditures Committee Resolution on the County Auditor

The Revenue & Expenditures Committee is submitting a resolution on the Arlington County auditor for membership approval at the April 21 meeting. This resolution states in major part that *the Arlington County Civic Federation asks the County Board and County Manager to identify additional funding and/or staffing resources (for example, adding a forensic accountant or a compliance officer) to support the County Board Auditor’s ability to complete audits and follow-up reviews within the established audit work plan’s time-frame and to increase overall audit capacity, in order to deliver timely, independent analysis to the County Board and assure Arlington County taxpayers that revenues and fees are being used in the most effective and efficient way possible.*

Livability Resolution

Whereas, the Arlington County government has made a decision to increase residential and commercial density,

Whereas, there is not a current guiding document that addresses the impacts of increased density, and that integrates existing county plans and documents,

Whereas, the scale of the proposed developments’ impacts exceeds the scope of customary planning reviews,

Whereas, there is not a process that incorporates input from the direct and indirect communities impacted by the increased density at the scale being proposed,

Whereas, the Arlington County government has committed to increased engagement by residents,

Whereas, the Livability Framework , “[Livability22202 Action Plan](#)”, being

developed by the three neighborhoods adjacent to Amazon's proposed new Headquarters 2 (Aurora Highlands Civic Association, Crystal City Civic Association and Arlington Ridge Civic Association) may have some applicability and usefulness in other areas of the County;

Whereas, all areas of the Arlington County depend on the revenue generated from development in the 22202 area,

Now therefore be it resolved that *the Arlington County Civic Federation:*

- 1. Supports the development of the Livability Framework as a tool for reviewing impacts holistically, including both the proposed building site and its neighboring communities;*
- 2. Calls on the County to acknowledge the creation of the Livability Framework and recognize the viability of the Livability Framework for tackling development challenges with holistic strategies based on shared livability themes to maintain and create better, more livable areas.*

COMMITTEE REPORTS AND ANNOUNCEMENTS

Cultural Affairs Committee - April 2020

Since the last newsletter in March, COVID-19 has altered our lives. With recent correspondence from leadership at the Arlington Arts Commission and Embracing Arlington Arts, this update provides a glimpse of the cultural affairs in the County.

During these unprecedented times, Arlington artists, arts and cultural organizations are continuing to promote creativity, foster learning, and provide much-needed (and often healing) human connection for the residents of Arlington County and the DMV. From virtual dance and fitness classes, streaming of theatrical, music, and opera performances, curricular resources for teachers and students, to adult art-making activities, our arts groups have turned on a dime, moved programs online, and created new offerings. At the same time, they are struggling with their finances, trying to keep staff on board, and, like so many small businesses, applying for loans and relief from the various CARES Act (and other) programs, and seeking donations from an equally cash-strapped or financially uncertain public.

In the past year, the County Manager, senior County staff and County Board members brought together county staff and community arts stakeholders to address issues related to costs and efficiencies regarding the scene shop, costume shop, mobile stage, and the joint use agreement with Arlington Public Schools. The outcome produced viable solutions with many enacted or included for consideration in the County Manager's FY 2021 Proposed Budget.

Given the extraordinary circumstances our community is facing, the County Manager has reformulated the FY 2021 Proposed Budget. In the [Revised FY 2021 Budget Memorandum](#), County Manager Schwartz is proposing to retain two critical staff positions in Cultural Affairs and maintain the base level

funding of the Arts Grants Program. Additionally, he is proposing to postpone the Signature Costume Shop Management program. Marsha Semmel, chair of the Arts Commission has submitted a report for the April 16th Budget Work Session.

OTHER ANNOUNCEMENTS

Community Emergency Response Team Training

The nationwide Community Emergency Response Team (CERT) program is comprised trained volunteers who assist their communities when disaster strikes. Arlington County offers free biannual classes to train county residents, employees, and students on how to help themselves and others until emergency responders arrive. The biannual Arlington CERT basic training program (CBT) involves approximately 30 hours of online, classroom and hands-on training and concludes with a final training exercise before graduation. In the CERT basic training program , you will learn disaster preparedness, disaster medical operations, light search and rescue, team organization, disaster psychology, fire suppression and terrorism.

One example of what CERT members do was evident in July 2019 after the severe weather that caused widespread flooding and significant damage to public facilities, roads, businesses and homes. Volunteers from Arlington CERT, the Virginia Medical Reserve Corps (MRC) and Team Rubicon trained and mobilized to go door-to-door to assist with damage assessments in the County.

Are you ready to join the over 800 volunteers trained by Arlington CERT? The spring training sessions start in April and the fall sessions in September. Each session includes eight classes that meet on six weeknights (either Tuesdays or Thursdays) and two Saturdays. All classes meet at the Arlington Fire Training Academy in Shirlington and are taught by Arlington County Fire and Police Departments (ACFD, ACPD) and Arlington County Emergency Management staff (OEM), as well as active duty CERT members. The minimum age to attend is 14.
