### Arlington County Civic Federation (“ACCF”) Membership Meeting

**Call to Order:** Federation President Gajadhar noted the presence of a quorum and called the meeting to order at 7:02 PM. President Gajadhar led the meeting in reciting the Pledge of Allegiance.

**Meeting Format:** The meeting was held using Zoom. President Gajadhar was the Administrator to begin with and then shared the duty with Board Member Tina Worden. The meeting Waiting Room URL was listed in the email newsletter along with the password. Ms. Worden, Dennis Gerrity and Chris Worden controlled entry into the meeting and the voting process. Voting was done with Constant Contact emails sent to the Delegates.

The Treasurer’s report for June was in the September Newsletter. The minutes for the June 16th Membership Meeting were submitted and voting emails were sent. The vote to approve: For: 40, Against: 1, Abstain: 0

**Member Attendance:** Ms. Worden kept roll as the Members and Observers were allowed into the meeting. There were 117 Total Attendees with 66 Members and 51 Guests. **2020 Candidates Forum:** Candidates for four offices came. After giving their positions they took questions that had been submitted by the members to President Gajadhar..

**Senate:** Daniel Gade (R)

*What are the most important challenges facing our country and how do you propose to address them? Are there opportunities for Democrats and Republicans to find common ground on these issues? What measures do you support to improve and secure elections and voting in our country? Do you support removing the ratification deadline for the Equal Rights Amendment? Please tell us your position on the future of the National Endowment for the Arts.*

**County Board:** Libby Garvey (D), Audrey Clement (I)

*Please indicate what county services or programs represent your top two priorities for the coming year and explain why. What creative solutions can you suggest to resolve a lack of affordable childcare and quality Pre-K programs? What regulatory and financial roadblocks can you help remove? If affordable housing opportunities should be distributed more equitably across the County, rather than being concentrated in limited neighborhoods, what are your recommendations for getting that done? If elected, what policies will you pursue to reform the county's policing and criminal justice systems? What is your top priority for a program or policy that will help achieve the goals of the 2019 Equity Resolution. Arlington has a significant water management and infrastructure issue that will not be resolved with more and bigger pipes or using park streams for storm water runoff. What is your plan?*

**School Board:** Cristina Diaz-Torres (D), David Priddy (D), Symone Walker (I)

*APS currently faces a budget deficit. With plausible additional budget cuts from the State and County for next year, how do you anticipate covering the revenue loss not just this year, but in the next school year as well? Given the overwhelming support in the County for more greenspace, are you prepared to agree now to "take off the table" for consideration all of the listed parks other than those which were originally school sites? What do you think needs to be done to have better coordination with the county board on growth projections and facilities planning? School Board races are by law non-partisan, yet the parties limit competition by endorsing candidates and requiring pledges and loyalty oaths to support the candidates who win their endorsement process. Do you agree with this process? Does Arlington currently have the right balance of resource allocation and/or programs to close achievement gaps, engage the majority mainstream students, and challenge the gifted? What steps would you recommend to bolster teacher retention?*

**Representative (District 3):** Don Beyer (D), Jeff Jordan (R)

*If your party takes the White House, Senate, and House -- what would be your top piece of legislation that you would reintroduce. ### **Resolution to Establish an Arlington Governance Taskforce**

At its July meeting, CivFed's Board of Directors approved bringing to the membership a resolution establishing a Task Force to examine, and propose reforms, for Arlington's form of government. It has been ninety years since the at-large Board of five part time members replaced the prior system of district commissioners, and in that time Arlington's population and complexity of government have increased many fold. Possible reforms to be considered by this task force include:

1. Structural reform through district representation and/or multi-member synchronous elections.
2. The size and/or remuneration of our county board and/or school board.
3. Ranked choice voting for County Board and School Board general elections.
4. The future role of primaries and caucuses.
5. Options for alternative electoral mechanisms besides first past-the-post and ranked choice.
6. Term Limits

Principals that will inform the Task Force's work will include, but not be limited by the following:

- To improve the quality of our elected officials' representation and policy making,
- To improve citizen engagement and voter turnout,
- To improve our Board's ability to reflect the opinion and diversity of our communities
- To improve the quality and diversity (more choices--more voices) of our candidates and campaigns.
