Minutes May 23, 2021

Arlington County Civic Federation ("ACCF") Board of Directors Meeting

Call to Order at 6:03 p.m.

They sent me a filled out Member Certification. I told them to fill out a Contact Sheet, provide a list of 20 members who live or work in Arlington and send a check to the Treasurer. They have not done so. Alistair Watson has been involved in this.

The County FOIA Office could not find any reference in their records of a MOU between CivFed and the

County concerning Civic Association name changes and boundary disputes. If there ever was a written agreement it has been lost.

Jesse: Was the final decision made on what people need to submit? I thought we had made changes about the addresses and things like that. Has that already been approved? Allen: The application requirements are already in the Bylaws
