# Arlington County Civic Federation ("ACCF") Membership Meeting

**Call to Order**: Federation President Gajadhar noted the presence of a quorum and called the meeting to order at 7:01 PM. President Gajadhar led the meeting in reciting the Pledge of Allegiance.

**Meeting Format:** The meeting was held virtually using Zoom. President Gajadhar was the Host. BOD Chair Eric Cassel was Co-Host.
