President's Corner

Welcome to the 106th season of the Arlington County Civic Federation!
It is election season, the time of year when we exercise our Constitutional right to self-governance.

Our membership meeting on September 14th is our annual Candidates' Night,

where nominees will present their positions to us, and answer questions. We hope that you will join us. See below for further details.



Our new Civic Federation Board of Directors met over the summer to begin a strategic planning process. Newly elected Board Chair Nicole Merlene facilitated the process whereby we decided on an overall objective for the Civic Federation, and 4 strategic goals. The Board continues to work to develop key strategies to achieve these goals in support of our objective.

The stated objective of the Civic Federation is to enable Arlington to be a place that works for everyone.

This objective aligns with our stated purpose in our Articles of Incorporation, which is to be a civic organization that supports the general welfare of Arlington County and its vicinity in a non-partisan, non-sectarian, non-sectional, and non-political manner.

As the Board further develops the goals and strategies, we will provide additional updates to the membership. I am proud of our new Board of Directors, and the commitment they all have to the betterment of Arlington.

The Board also determined our dues for the coming season, the details are documented elsewhere in this newsletter.

We have decided to meet on the 2nd Tuesday of the month this season. This is to minimize schedule conflicts with other county meetings, including board meetings. Also please note that our Membership Meetings will continue to be virtual at least through December.

Our committees have a full slate of activities this year.

The Task Force in Governance and Election Reform (TiGER) is moving into their recommendation phase, they will be presenting their recommendations in November. The Public Services and Legislation Committees will be sponsoring a panel on data privacy, focusing on the Clarendon Safety and Innovation Zone.

Additionally, the Revenues & Expenditures Committee will be looking at the County budget, and the Housing Committee, Environmental Affairs Committee, and the Parks and Recreation Committee will all be looking at these aspects of County life.

We will also host the County Board, the School Board, Superintendent, and the County Manager this year.

After the past year living with the pandemic, life is returning back to normal in many ways. Schools are reopening, many people are traveling for vacations, and stores and restaurants are largely reopened. Although there has been a fair amount of turmoil in the last year, Arlington, and society as a whole, has proven its resilience and community spirit in how we collectively have responded to the upheavals of the last year.

I am proud to live in such a resilient, diverse, and caring community, and to lead the Civic Federation in its shared mission of an Arlington that works for everyone.

Environmental Affairs Committee Update Progress on report from 5/22/21 Second Public Collaborative on Preserving Arlington's Tree Canopy

Second Public Collaborative work has continued this summer in six teams. The teams explored the concerns identified with the participation of a range of stakeholders. The work generated solutions and strategies for mitigating Arlington's tree loss. The results will be reported to the membership this fall. The teams are focusing on these topics:

- Improving County management of our urban forest
- Financial and other resourcing for tree programs and activities
- Incentives for developers to preserve trees
- Zoning affecting tree preservation
- Enhancing enforcement under current regulations
- Correcting current inequities in the tree canopy
