Public Services Committee Stormwater Management/Flood Mitigation Work Group

Severe stormwater flooding in several parts of Arlington County in July 2019 dramatically revealed insufficiencies in the county's resilience and mitigation strategy. ACCF has responded with three major resolutions with specific and general recommendations for improvements. The stormwater group of the Public Services Committee is pleased to offer to the Civic Federation membership on February 8th its fourth stormwater resolution, which is linked [here](#).

This resolution was presented at the January membership meeting, and urges both strategic and tactical changes in the county's approach to stormwater flooding and its growing climate change-driven threat. The resolution is designed to be available to the County Manager's staff as it prepares the county's FY 2023-2032 Capital Improvement Plan to come before county voters in November.

The Civic Federation's stormwater group has been working closely with county staff, senior members of whom will offer a brief background presentation on February 8. The presentation will also detail the ACCF stormwater group's efforts to encourage civic associations in the same watershed to engage as a group with the county to pursue improvements in their particular watersheds. There will be time for questions from the membership immediately following the presentations.

Residential Assessments Rise Again in 2022

As we consider Arlington's fiscal year (FY) 2023 budget, it's worth reviewing how we get the money to run our government. Over 70% of local tax revenue comes from commercial and residential real estate taxes.

Altogether, real estate revenue represents 60% of the county's total revenue, with residential properties contributing 54% and commercial properties contributing 46% in 2022.[1] Residential property owners have seen their share grow with soaring home prices while commercial property values, in many cases, have declined during (and even before) the pandemic. As recently as 2019, the commercial share was 49%, with residential's share at 51%.[2]

In 2022, overall commercial property assessments increased 0.6%, up from a 1.4% decline in 2021 but far lower than the 4.9% increase in 2020. Apartments and hotels offset value declines in other types of commercial properties in 2022.[3]

Overall residential real estate assessments are up 5.8% in 2022, larger than the 5.6% rise in residential assessments in 2021 and the 4.3% increase in 2020.[4] Sounds like good news, right? In truth, rising property values are a mixed blessing—increasing county revenues, but also your tax bill.

Even when the real-estate tax rate remains the same—\$1.026 per \$100 of assessed value in 2021 and 2022[5]—your tax bill goes up when your real estate assessment goes up, unless the county reduces the tax rate sufficiently to fully offset rising assessments.

In dollars, the average “single-family” homeowner has seen his/her real estate tax bill (not including other local taxes or fees) rise from \$4,977 in calendar year (CY) 2012 to \$7,338 in CY2021—a 47% increase.[6]

Assessment increases’ cumulative impact means the average homeowner now pays, on average, \$2,361 more per year in additional property taxes than were paid in 2012.

What about renters? Yes, renters **DO** indirectly pay property taxes, which are baked into rents for apartments[7] and are often a pass-through surcharge paid (on top of rent) by commercial tenants.[8]

Consequently, rising property tax bills—via assessments or the tax rate—increase housing costs and make homeownership and renting even less affordable for those living on lower or fixed incomes[9] as well as those who have experienced pandemic-related financial hardship. They can also make Arlington’s commercial space less competitive and less attractive.


Northern Virginia Families for Safe Streets (NoVA FSS), with chapters in Alexandria, Arlington, and Fairfax, is identifying locations across all of Northern Virginia where pedestrians and cyclists have experienced near miss incidents and other dangers, by offering the Near Miss

A near miss incident is an event in which a driver of a vehicle or a person walking, running, biking, or scooting had to suddenly stop, swerve or otherwise move to avoid a collision. A dangerous location is deemed dangerous to a person walking or biking.

This information is reported anonymously to regional municipalities and other transportation focused organizations to identify locations that would benefit from safety improvements but may have not been determined to be problem areas by traditional crash data sources.

Our goal is to improve safety for area residents, employees, and visitors. Please join us in our efforts to capture information about dangerous locations and behaviors.
