We are now officially in the County and Schools budget season. Our Revenues and Expenditure (R&E) Committee, and Public Services committee have been evaluating the County Budget and CIP, they will be reporting their analysis to the membership, along with a potential resolution. We will be discussing and voting on the proposed



[R&E resolution on the tax rate](#) at the March meeting.

Waverly Hills delegate Todd Truitt has been named chair of the Schools Committee. They are in the process of evaluating the Superintendent's proposed budget. They will report their findings and a potential resolution in advance of the May Membership meeting, when the School Board will be our guests.

The Public Services Committee Stormwater [resolution](#) was approved by the membership at the February membership meeting. John Ford and the Stormwater working group are engaging with Civic Associations all over the County and with County Staff to work to address ongoing issues and plans for Stormwater Management and Flood Mitigation across the County. The Civic Federation has been in the forefront of advocating for similar issues since its founding, we are encouraged by the County's willingness to engage and respond.

Also at this month's membership meeting, the Public Service Committee will be presenting on a panel on the new Marcus Alert system. Further information is below in the newsletter.

Finally, we will be voting on a nomination committee at the March Membership meeting. This committee will handle the nomination of at least one candidate Voting Member or Alternate Member for each Director position, including Civic Federation Officers. We will send proposed members of the nominations committee out in the meeting reminder before meeting on March 8<sup>th</sup>.

### **Panel: What is the Marcus Alert System and What Does it Mean for Mental and Behavioral Health Equity in Arlington?**

The Marcus-David Peters Act, signed into law in 2020, requires that all Virginia localities establish a local plan with protocols for first responders and behavioral health professionals when responding to a crisis related to mental health, substance abuse, or developmental/intellectual disability. The implementation aims to achieve positive outcomes for individuals experiencing a behavioral health crisis, as well as diverting individuals away from the criminal justice system towards resources for treatment and recovery. DHS identifies success for the system to include "increasing the availability of, and access to, racially responsive crisis supports, with a focus on equity and safety to ensure the most optimal outcomes."

Arlington has been working with partners and stakeholder groups to design the Arlington framework and is now in the stage of deciding on short-term steps, mid-term plans, and long-term goals. Although pending legislation may extend the deadline, the current deadline for submitting the plan is this May 2022.

What new programs are under consideration? How will current programs be modified or expanded? How are programs for youth included? What specific protocols and programs are being developed by DHS and ACPD to transition behavioral health and law enforcement to fully implement the Marcus Alert and last year's recommendations from the Police Practices Group? How will implementation work with the current national and local staffing crisis for both behavioral health and law enforcement professionals?

The plan that Arlington adopts will set the context for Arlington's future response to people in mental or behavioral health crises and for Arlington's commitment to equitable services for prevention and treatment.

The Civic Federation will provide a presentation on the current status led by Deborah Warren, Deputy Director, Department of Human Services who is the lead for developing the plan. The panel will include partners from the Arlington County Police Department, Lieutenant Steve Troyano, and Heather Horan from the Emergency Call Center (ECC/911), Public Safety Communications and Emergency Management Office (PSCM).

There will be an opportunity through the chat for questions and feedback.

## **APS Superintendent Visit to Civic Federation**

Arlington Public Schools Superintendent Dr. Durán made his annual visit to the Arlington County Civic Federation at the February 2022 membership meeting. He gave a 40-minute presentation, followed by 20 minutes of Q&A from the audience. The presentation covered topics and subtopics requested by the Schools Committee. APS also provided answers in advance to the Schools Committee's written questions.

The Arlington County School Board is scheduled to make its similar annual visit at Civic Federation May 2022 membership meeting. The Schools Committee will be similarly working with the School Board in advance in requesting topics and subtopics for that presentation.

## **Legislation Committee Update on Deaths in Arlington Detention Center**

On February 1, 2022, Paul Thompson died while in custody at the Arlington Detention Center. His is the seventh custodial death at the jail since 2015. Three of those deaths occurred in the last 15 months. According to news reports, Mediko Correctional Healthcare has been the medical services provider at the jail since November 16, 2021 and was the provider at the time of Paul Thompson's death. Three investigations are now open and pending, including an investigation into the October 1, 2020 death of Darryl Becton. Following the death of Clyde Spencer on October 5, 2021, the Civil Rights Working Group issued records requests to the Arlington County Manager, the Arlington County Sheriff's Office, and the Arlington County Police Department for information relating to a series of deaths at the jail. The scope of the requests were narrowly tailored to obtain records subject to release under the Virginia Freedom of Information Act (Virginia FOIA).

The Arlington County Police Department (ACPD) produced responsive records on November 23, 2021. Records produced by ACPD include policy documents, emergency logs and other investigative records for four closed investigations from 2015, 2017 and 2019. The Police Department withheld records relating to the more recent deaths of Darryl Becton (died October 1, 2020) and Clyde Spencer (died October 5, 2021).

On October 27, 2021, The Arlington County Sheriff's Office invoked a provision of state law seeking a 60-day extension. Following a status inquiry on February 4, 2022, the Sheriff's Office confirmed that responsive records had been collected some time ago, and had been passed on to an attorney for review.

On February 10, 2022, the Sheriff's Office finally responded with a cover letter and a limited number of records. Released were policy documents, the inmate manual, a single directive dated October 23, 2020 relating to alcohol withdrawal, and a contract with Corizon Health. The contract with Corizon was terminated on or about October 25, 2021. The Sheriff's Office has withheld all other requested records, claiming they are not subject to disclosure under state law.

The County Manager's Office has not formally responded to the records request.

The Civil Rights Working Group is reviewing the adequacy of the responses and will follow up as appropriate.
