This month, we have a presentation from the Task Force in Governance and Election Reform (TiGER), where they will present their recommendations on changes to the County's government and voting process. This represents the culmination of a long

process led by Chris Wimbush, and a number of volunteers to recommend reforms that will make the County and School Boards more effective, efficient and representative.

As a reminder, their mandate was to:

“... examine and potentially make recommendations on reforms which might include:

- 1) Structural reform through district representation and/or multi-member synchronous elections;
- 2) The size and/or remuneration of our county board and/or school boards;
- 3) Ranked choice voting for County Board and School Board general elections;
- 4) The future role of primaries and caucuses;
- 5) Options for alternative electoral mechanisms besides first-past-the-post and ranked choice.
- 6) Term Limits



Principals that will inform the Task Force’s work will include, but not be limited by the following:

- To improve the quality of our elected officials’ representation and policy making,
- To improve citizen engagement and voter turnout,
- To improve our Board’s ability to reflect the opinion and diversity of our communities
- To improve the quality and diversity (more choices--more voices) of our candidates and campaigns." From the [Board Resolution authorizing the Task Force](#).

We look forward to their recommendations, and to engaging with elected officials to implement these recommendations.

The Cultural Affairs Committee will be presenting at the April membership meeting, as will the Stormwater working group; see details elsewhere in this newsletter.

As you all know, we have conducted our meetings virtually for the last two years due to the pandemic.

I am pleased to report that the Hazel conference center is once again allowing outside groups to meet, and we are in discussions with them to determine the date of our first in-person meeting, potentially our May meeting.

Stay tuned for further communications on this topic.

Do note that regardless of when we return in-person, my intent is to continue with an online presence for those who do not wish to attend in person.

This will involve some planning to ensure engagement by both remote and in-person attendees during meetings; we will be working on that over the next month.

There has been a lot of discussion regarding the County’s residential tax rate, and how it relates to the budget. The Revenues and Expenditures Committee are monitoring the situation and will report back to the membership as required.

Cultural Affairs Committee

At the May Membership meeting, the committee will host an update from Plan Langston Boulevard (PLB). This has been multi-year planning process that began in 2016 that continues its’ efforts towards achieving completion.

Lately, there has been widespread concern in the artist community and by residents in and around the neighborhood over the future of the Lee Arts Center which is located within the PLB study area.

This planning effort impacts the entire Langston Boulevard corridor and as a result impacts many of our member associations. We look forward to hearing from PLB leadership on May 10.

On another topic, the Civic Federation was invited to participate in the Bozman Public Art Community Technical Advisory Panel (CTAP).

ACCF president, Allan Gajadhar approved Tina Worden, chair of the Cultural Affairs Committee to serve in this role. The panel will begin its' work later in April.

This is a wonderful and meaningful opportunity for the Civic Federation to represent our membership in the selection process of a significant public artwork that will sit at the heart of our government center.

The role is a preliminary step towards defining goals used to guide the artist selection for public artwork that will be suspended over the lobby of the Ellen M. Bozman Government Center during its' renovation. The integration of public art into our government center will allow for the celebration of civic space and civic life in Arlington.

The Community Technical Advisory Panel is comprised of County residents and staff who have been recommended by the County Managers Office. The CTAP will help define goals for the public artwork and review a visual preference survey. The CTAP will meet up to four (4) times over the next several months.

Rising Residential Assessments/Tax Burden: Resolution and Report

With the fiscal year (FY) 2023 \$1.47 billion budget's approval imminent, R&E has examined assessments with an eye toward the real estate tax's regressiveness^[1] and residents' (owners' and renters'^[2]) growing tax burden.

Residential property owners have witnessed assessments soar along with home prices. In calendar year (CY) 2022, residential assessments have risen 5.8%, higher than the 5.6% and 4.3% increases in 2021 and 2020, respectively.^[3]

Apartments and hotels—both considered “commercial” properties—also saw property assessment increases overall in CY2022.^[4]

A double-edged sword, rising property values provide the county with a revenue windfall but likewise increase residents' tax bills. The average homeowner has seen his/her real estate tax bill rise from \$4,977 in CY2012 to \$7,726 in CY2021, now paying, on average, **\$2,361 more per year** in additional property taxes than were paid in 2012^[5]

Even when the base real-estate tax rate remains constant—\$1.013 per \$100 of assessed value in 2021 and 2022^[6]—tax bills rise when assessments increase, which is called the “effective tax rate increase” (a \$0.023 increase in FY2023 for \$1.036/\$100).^[7]

The county can reduce the tax rate (called the “lowered rate,” a \$0.023 decrease for FY2023 to \$0.99/\$100) to offset rising assessments while still reaping revenue equal to or above the amount collected in the previous year (roughly \$30 million in additional

revenue even at the lowered rate).[8] State law[9] requires the *effective* and *lowered* rates to be advertised, but few taxpayers see the notice.[10] Likewise, the County Board typically focuses on the base or nominal tax rate in its guidance to the County Manager, if it mentions the tax rate at all.

Though many struggle with housing costs, one in 10 Arlingtonians is 65+[11] a group frequently vulnerable to cost hikes (including real estate taxes).[12] Low-income Arlington seniors are heavily concentrated in three ZIP codes—22202, 22203 and 22204—where the county tends to be more diverse.[13]

So how is the county using its 5.8% residential revenue windfall? Most of the 5.5% FY2023 budget increase appears to be earmarked for 115.5 new full-time-equivalent (FTE) county positions,[14] even though over 400 existing positions (10%+ of the county workforce) remain unfilled.[15] How surplus funds (left over when positions remain unfilled) are used is complicated and remains somewhat unclear. In its [Real Estate Assessment and Tax Burden Resolution](#), R&E urges County Board members to consider adjusting their annual budget guidance[16] to the County Manager so that it fully integrates the impact of the effective rate increase on residents and businesses earlier in the budget planning process so that the manager can better balance new spending with reasonable mitigation of the growing tax burden.

Public Services Committee: Stormwater Utility Update

Over the past 15 years, an escalation of heavy rainstorms has devastated Arlington homeowners and commercial interests, public infrastructure and private property, culminating in flooding in July 2019 and July 2020 and clearly exposing weaknesses and inadequacies in the county's stormwater mitigation infrastructure. County engineers and program managers have responded with a successful \$51 million bond issue in 2020; updated plans and proposals pursuant to the County's 2014 Stormwater Master Plan, and a nimble response to a stormwater crisis in the Westover area following the 2019 deluge.

The Civic Federation has encouraged such positive responses and urged greater ambition in seeking adequate funding to properly protect county residences and businesses. In several resolutions since 2019, ACCF has specifically supported the county's efforts to explore the feasibility of a stormwater utility, among many other recommendations. County response has generally been encouraging.

But County financial stormwater resources, traditionally funded by a targeted supplement to annual property tax bills, are insufficient and inequitably impose tax burdens on property taxpayers. As the result of a multi-year exploratory period, the County is moving to recommend that the County Board approve establishment of a stormwater utility to ensure a steadier stream of funding to support operation, maintenance and improvement of the County's aging and inadequate stormwater infrastructure.

The proposed utility would prospectively come online in FY 2024, and in establishing it, Arlington would bring its procedures into line with a widely accepted government model for funding stormwater remediation. A stormwater utility is presently in effect in Falls Church, Alexandria and in most major metropolitan areas in Virginia.

At its April membership meeting, the Public Services Committee and County staff will offer to ACCF members a summary overview of stormwater utility developments to date, as well as a timetable for implementation and a glimpse at how the tax burden of stormwater remediation would prospectively be redistributed.

This presentation will represent the start of a major county outreach over the next six months to better inform residents about a prospective stormwater utility. Our individual feedback will be actively solicited.
