## County Board Passes \$1.5 Billion Budget

On 4-26-2022, the County Board passed the FY2023 budget, a “7.6% revenue and spending increase over the current fiscal year, which ends on June 30.[1] The total tax and fee burden for the average Arlington household was estimated to be \$505 in additional taxes and fees, for a total of \$10,138.[2]

Prior to the budget’s passage, CivFed President Allan Gajadhar transmitted the ACCF’s

approved “Real Estate Assessment and Tax Burden Resolution”[3] as well as its supporting report[4] and FOIA attachment[5] to the Arlington County Board via a letter dated 4-17-2022.

Pres. Gajadhar reinforced the resolution’s message during public comment during the County Board’s regular meeting on 4-23-2022. The board’s response was reasonably polite and receptive. View the video here (starts at 4:34 on the time counter): <https://www.youtube.com/watch?v=MnWNLUI4zDs>.

Below are follow-up remarks to some of the board comments:

- Arlington’s nominal tax rate may be low compared to its Northern Virginia peers, but its assessed property values (and thus its tax bills) are among the highest.[6] [Calculate your tax bill by multiplying the nominal rate by the assessed property value and then dividing that figure by 100.]

- The *effective tax rate* (the rate we actually pay) includes the impact of those higher assessments.[7] In FY2023, the effective tax rate will be 2.3 cents higher than the nominal rate—or \$1.036 versus \$1.013 per \$100 of assessed value. NOTE: These nominal and effective rates do NOT include the stormwater or transportation commercial property tax surcharges, which further increase real estate tax bills.

- Let’s compare how much Arlington, Alexandria and Fairfax will spend per person in FY2023:

—Arlington = \$6,276.7

—Alexandria = \$5,265.4

—Fairfax = \$4,145.3

- Even if Arlington had lowered its nominal rate by 2.3 cents (to fully offset this year’s assessment increase), the county still would have received \$30 million more in new, ongoing revenue from real estate taxes.[8] The county also found \$27 million in excess funds (unallocated and unspent) left over from FY2022[9]—a total of \$57 million in revenue (roughly equal to 6.7 cents on the tax rate) available for new spending in FY2023.

- Arlington typically pays more in revenue to the state than it receives back, but Arlington also benefits from the \$573 million in state cash grants for Amazon’s HQ2, part of the \$1.8 billion in total government outlays to win the HQ2 sweepstakes.[10]

The Arlington County Civic Federation and the Revenues & Expenditures Committee will continue to communicate with the Arlington County Board to push for budget guidance, going forward, that will require the manager to take into account the impact of the effective tax rate increase (increased assessments) on county residents—especially vulnerable populations—and businesses in order to balance new spending with reasonable mitigation of the growing tax burden.

## Public Services Committee: Stormwater Utility Update

County staff will join the ACCF public services committee in offering to members updates on the stormwater mitigation component of the 2023-2032 Arlington County Capital Improvement Plan. The CIP is still in preparation at this writing, but a public release is presently scheduled for May 14, so we should get at least a broad overview of the stormwater priorities represented in the CIP.

Additionally, the SUCAG (stormwater utility citizens advisory group) has continued to meet since our April membership meeting, and some clarification will be available to issues our members and others from the public have raised in the intervening month. Background on the County stormwater program and its current importance is repeated below.

Over the past 15 years, an escalation of heavy rainstorms has devastated Arlington homeowners and commercial interests, public infrastructure and private property, culminating in flooding in July 2019 and July 2020 and clearly exposing weaknesses and inadequacies in the county's stormwater mitigation infrastructure. County engineers and program managers have responded with a successful \$51 million bond issue in 2020; updated plans and proposals pursuant to the County's 2014 Stormwater Master Plan, and a nimble response to a stormwater crisis in the Westover area following the 2019 deluge.

The Civic Federation has encouraged such positive responses and urged greater ambition in seeking adequate funding to properly protect county residences and businesses. In several resolutions since 2019, ACCF has specifically supported the county's efforts to explore the feasibility of a stormwater utility, among many other recommendations. County response has generally been encouraging.

But County financial stormwater resources, traditionally funded by a targeted supplement to annual property tax bills, are insufficient and inequitably impose tax burdens on property taxpayers. As the result of a multi-year exploratory period, the County is moving to recommend that the County Board approve establishment of a stormwater utility to ensure a steadier stream of funding to support operation, maintenance and improvement of the County's aging and inadequate stormwater infrastructure.

The proposed utility would prospectively come online in FY 2024, and in establishing it, Arlington would bring its procedures into line with a widely accepted government model for funding stormwater remediation. A stormwater utility is presently in effect in Falls Church, Alexandria and in most major metropolitan areas in Virginia.

## The Columbia Pike Documentary Project

The Columbia Pike Documentary Project work of a collection of artists who have been intensively documenting the diverse and rapidly-changing Columbia Pike since 2007. The Pike has been referred to as a "World in a Zip Code," with well over 100 languages spoken. The thousands of striking photographs of the people and places along the Pike, and the moving in-depth interviews with a range of citizens and business owners have been published in two books; Living Diversity and Transitions, displayed in numerous major exhibitions, and featured on WETA, WAMU, ArlNow, Richmond magazine, and Voice of America. The work, largely funded by Virginia Humanities and the Arlington Commission for the Arts, and sponsored by Columbia Pike Partnership, is permanently archived at the Library of Virginia in Richmond.

### **Our work is available for presentation to civic association groups.**

We have a compelling slideshow of our striking photographs and four portable pop-up banners that serve as a mini gallery that we can share, along with our talented artists (Lloyd Wolf, Sushmita Mazumdar, Xang Mimi Ho, Dewey Tron, and/or Lara Ajami) as guest speakers.

We have successfully shown our work to the Penrose civic association and are slated to do so with Glencarlyn's.

**We would be happy to share with any group in the County that is interested in our area's vibrant history, arts, culture, neighborhoods, diversity, local businesses, and local architecture.**

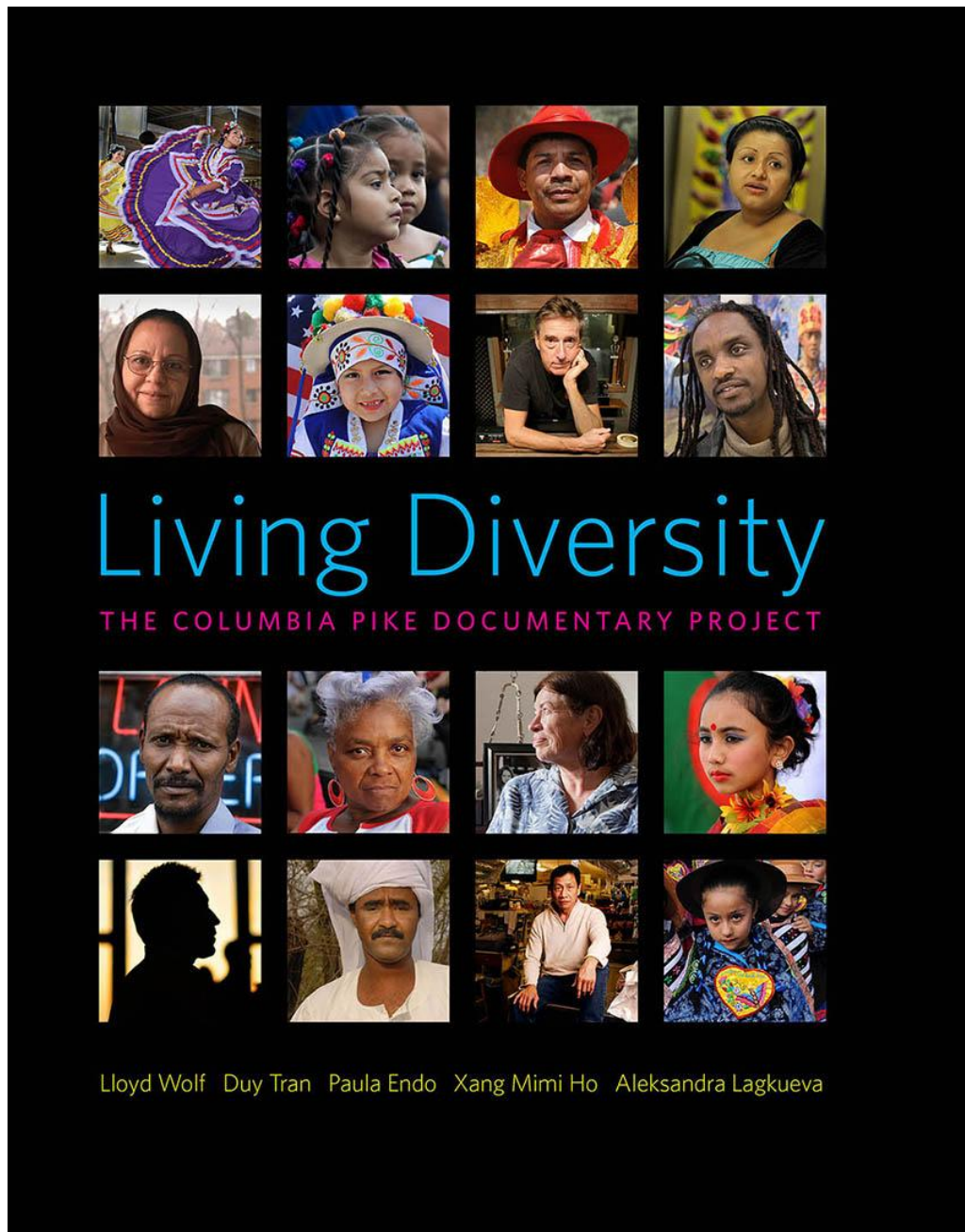
