# **NEW BUSINESS (John Ford)**

- Annual Picnic (Todd Truitt Schools Committee chair)
  - Reminder: 1<sup>st</sup> annual picnic on June 25<sup>th</sup> at Lyon Park community center. Looking for volunteers, see newsletter.
  - There is a nationwide substitute teacher shortage. Requested members consider becoming a substitute teacher.
- Restore the Public's Trust in Arlington County Government (John Ford)
  - John offered praise to those that worked on the 'Restore Public's Trust' resolution, indicated his commitment to a full review of the resolution in February, and noted the diversity of opinion on the resolution. John then opened the floor to questions.
  - Duke Banks <u>raised a Motion</u>: "To vote on the Restore resolution, substantially as is, at the February meeting."
  - A lengthy discussion amongst members ensued, with varying concerns raised by members:
    - A vote on the resolution was delayed 3-4 times
    - Concern raised about whether the resolution was vetted through CivFed committees. John Ford provided input that the committees were requested to review however some of the committees, notably Planning/Zoning and Housing are not fully operational.
    - Resolution is very verbose
    - Duke indicated that we will be voting on the resolution and not the appendix
