President's Message

Every CivFed member knows by now that we have a highly unusual situation this year in Arlington. There are two County Board positions to be contested in the November election, and neither one of them has an incumbent seeking reelection. This doesn't happen very often in our county. There is also one School Board position up for election - also without an incumbent seeking re-election.

Once it became clear that neither Christian Dorsey nor Katie Cristol would seek another term, your CivFed began planning for a special Candidates Forum meeting at our April membership meeting. We agreed to invite every candidate who had declared by April 7, regardless of party.

The June 20th primary election will use the rank choice voting method to decide who the

Democratic Party County Board candidates will be. The Civic Federation is partnering with the League of Women Voters to clarify for voters how this will work. There is more information on this below.

Seven County Board candidates have accepted our invitation to join us at our April 11 membership meeting. The lineup includes Independent Audrey Clement and Democrats Maureen Coffee, Susan Cunningham, Jonathan Dromgoole, Natalie Roy, JD Spain and Tony Weaver.

The County Board Candidates Forum will begin at 7:05 and, after introductory remarks by each, will feature 45 minutes of questions from the in-person and Zoom audience. Concluding remarks by candidates will end at 8:25.

Democratic School Board candidates Angelo Cocchiaro and Miranda Turner will follow a similar agenda, including 15 minutes of Q & A and concluding by 8:50.

With so many candidates and so little time, we will especially appreciate (and enforce) brevity by questioners. Our meeting will be important for each candidate as they seek to establish an individual position and distinguish themselves from their opponents, so it will be important for us and them to offer the opportunity to do so. That necessitates short questions and answers.

The Arlington County Superintendent of Schools, Dr. Francisco Durán, will join us for our May 9 membership meeting. The second half of this program will feature candidates for the contested positions of Arlington and Falls Church Commonwealth Attorney and Arlington County Sheriff. And please remember that the School Board will be with us for our June 13 meeting.

2) Resolution to Restore the Public's Confidence

John Ford introduced presentations on the "commonalities, differences, and why" regarding the revised Public's Confidence in Arlington County Governance Resolution versus the proposed revised amendment. Presentations were led by:

Following the presentations, the CivFed delegates approved a suspension of the parliamentary rules which allowed for a side-by-side vote of the resolution as revised and posted versus the proposed amendment as revised and posted. The <u>original resolution</u> ultimately passed with 70% of the votes.

Ranked Choice Voting: Preparing for the June 20 Primary




The June 20 primary for the Arlington County Board will use Ranked Choice Voting (RCV).

Successful Public Meeting Reveals New Tree Canopy Loss -Only 33% Tree Cover, not 41% Advertised by County

Over 50 citizens concerned about the rapid loss of Arlington's urban forest heard the discouraging details of the new Arlington urban tree canopy study prepared by the Green Infrastructure Center (GIC). The experts provided participants with access to large maps showing the distribution of trees and the ecosystem services by neighborhood. Some neighborhoods had 17% less tree cover in 2021 than in 2016 due to overcounting trees in the earlier study and actual tree loss over the five years. The study went further to determine that, given the limited availability of planting space, the canopy cannot reach 41% and immediate action is needed to preserve the remaining 33%.

The new study employed the most current available 2021 aerial photography and 2018 LiDAR data (showing height) to create an improved set of information that was used to identify and analyze the urban forest and the many public services that it provides. In addition, neighborhood by neighborhood information on existing tree canopy, potential planting areas, canopy percentages for all parks, heat impacts, watersheds, etc. was provided.

During an extensive discussion and comment session, participants' observations and recommendations for future activity were recorded. Common themes were the need to enforce existing regulations/ordinances protecting trees, increased public funding for planting and tree maintenance, incentives for preservation of mature trees on private land, and increased investment in trees in public rights-of-way. There was consensus for a recommendation that these more current findings should be incorporated into the draft Forestry and Natural Resources Plan currently under development.

Plans to form a collaborative to continue efforts to preserve and enhance Arlington's trees were announced at the meeting. Tentatively named the Arlington Consortium for Tree Sustainability (ACTS), nearly two dozen participants expressed interest in continuing discussions. The Consortium would connect existing organizations and citizens to accelerate efforts to preserve and expand the urban forest. The full final report will be available in June and further developments can be followed at www.arltreeconsort.net.

In addition to your Arlington County Civic Federation, the meeting was sponsored by the Northern Virginia Conservation Trust and EcoAction Arlington and attended by the Faith Alliance for Climate Solutions, the Arlington/Alexandria Tree Stewards, and the Arlington Tree Action Group. There's a new issue which is ruffling lots of feathers now. It's pickleball. Arlington pickleball players have for several years asked the County to provide more and better pickleball court facilities. After a public engagement process that both the neighbors and organized pickleball players now believe fell short in both engagement and transparency, the County allotted \$2 million in the most recent Parks bonds to provide a number of courts at Walter Reed Community Center in South Arlington.

It's now clear that no one, even Parks planners or neighbors, could know what was coming, here as well as nationwide as the concentration of players in this new sport has met with rising neighborhood resistance. Now, after over 18 months, both neighbors and players truly understand the impact of noise, parking, and congestion at WRCC associated with the county's current and future plans.

Neighbors are especially impacted. They have been pushing back both on current temporary court provision and on the plan to spend substantial resources on making them permanent. Organized players, meanwhile, are insistent that any change of plans not result in any reduction of the currently planned playing space.

Arlington has been in the national news because of our growing Pickleball controversy. In response, Chairman Dorsey said at the last County Board meeting that the Board wants to hear from staff about this situation at its April meeting. Notably absent from the letter sent by Parks to the WRCC neighbors, however, was any invitation for input from stakeholders about the options and priorities to be discussed in that staff report.

Our meeting, March 29, discussed options for engaging the County during the upcoming weeks in order that CivFed representatives can engage with county staff to review and provide feedback on their report prior to its delivery to County Board members. Arlington Neighborhoods Advisory Committee (ArNAC)

Arlington County and the Arlington Neighborhoods Advisory Committee (ArNAC) are currently gathering ideas to help develop a vision for what potential projects and programming, offered through the Arlington Neighborhoods Program, could best serve our communities. We hope you'll share ideas and encourage others to share their ideas too.

Arlington Neighborhoods Program (ANP) has been in existence since 1964. Volunteer neighborhood Representatives selected from their Civic Association serve on the Arlington Neighborhoods Advisory Committee (ArNAC), which is comprised of 48 active representatives from Arlington's 57 civic associations. Together, they lead the development of neighborhood plans and recommend neighborhood-initiated capital improvements for funding by the County Board.

The program underwent a comprehensive review in 2019, resulting in the Neighborhood Conservation Program Review (NCPR) final report. The report included a recommendation to streamline and optimize programming. ANP is currently exploring potential changes and improvements to the core components of the program, which include Neighborhood Plans, ANP Projects, and ArNAC.

New ideas would be in addition to, not in place of, the traditional projects offered by the program. Today, the program provides funding for a variety of improvements including the installation of sidewalks, curbs and gutters, streetlights, signs, park improvements, neighborhood art, and beautification.

RESOLUTION TO MODIFY THE BYLAWS

At the April 2023 General Meeting, the Bylaws and Rules Committee will present a

proposed amendment to the Bylaws to align the dates for annual recertification and dues payments for Member organizations.

Prior to incorporation, there was no requirement for Member organizations to recertify their qualifications. There was also no written deadline for annual dues payments, rather a general understanding that dues should be paid by the close of the calendar year. The 2018 Incorporation Bylaws formalized a 31 December dues deadline and set a 31 October deadline for completion of the annual recertification process.

In the five years since the adoption of the 2018 Bylaws, experience has shown that the existence of two separate deadline dates has been confusing for Member organizations and burdensome for the ACCF Secretary and Treasurer who administer compliance and payment. The ACCF Board referred the matter to the Bylaws and Rules Committee with a request to review the deadline dates and determine whether a single deadline date might be advisable.

The Bylaws and Rules Committee concurs and advises a 20 November cutoff for both Member recertification and dues payment. The committee chose this particular date to (a) provide a single date to Member organizations, (b) allow a roughly three-month window for dues collection after the publication ACCF's annual budget, which generally occurs in mid-August, (c) be timed for a date immediately after a General Meeting, and (d) occur in advance of the busy and distracting year-end holiday season commencing with Thanksgiving.

The draft resolution was presented to the ACCF Board on 26 Febr 2023. The Board voted unanimously to send the Resolution to the General Membership for consideration.
