President's Message

Your Civic Federation May 14 membership meeting will feature a candidates' forum for the single County Board seat that will be on the ballot in November. According to our information, six candidates have formally declared for this seat so far – five Democrats and one Independent. CivFed is committed to impartiality in the conduct of its business and all six will be present at our meeting.

Over the past couple of years, I have discussed with many previous candidates for countywide office our fora and how we might improve them. One particular recommendation came from most, as well as from a couple of incumbent Board members: They urged us to offer an opportunity for our members to get to know the

candidates on a more personal level, in addition to their enunciating their views on the key issues of the day.

We aim to do that at our May meeting and will include questions that will enable our members to have a better idea of the candidates' connection to Arlington and how they enjoy our county.

But I and other CivFed leaders will also still devote most of our attention to issues like the county budget, housing policy, land use, planning and zoning and others we hear most about from our members. We do hope you will be able to join us in person next Tuesday, but as usual we will also offer a Zoom option for those attending remotely.

We will also make sure to include opportunities for questions from the personal and virtual audience – as always within our stringent time parameters.

I want to take this opportunity to solicit from our members your interest in and willingness to help us with two organization-building efforts that are coming up in the next few months.

The first is the annual Arlington County Fair, running from August 14 – 18 at the Thomas Jefferson Community Center on South 2nd St. We now have our own dedicated booth at the fair, and it is one of the best ways we have to get our message out to a large, curious audience. To do this best, we need help from our members in manning our booth and being available to respond to visitors' questions.

The second CivFed-wide event is a family picnic we are tentatively planning for a weekend afternoon in September or October. As we are all continuing to emerge from the isolation of the COVID years, your CivFed Board of Directors has been working to establish a new tradition for our organization – a family picnic in the autumn to offer a fun event for members and to also provide another opportunity for networking.

Our successful April banquet underlined for us the personal and networking importance of such organization-wide events, but as with our efforts at the county fair, we need help in planning and organizing the picnic. April General Membership Outbrief

CivFed sponsored a discussion on 'Arlington Wellbeing: Equity in Arlington Health and Access to Green Space'.

Jackie Snelling (CivFed Vice Chair of the Board) kicked off a discussion on equity across Arlington. The discussion included two related topics and panels of three speakers each.

First Panel: Arlington Well-being: Equity in Health

1. Dr. Rueben K Varghese MD, MPH; Director, Arlington County Public Health, presented: **'The "Body" Arlington: Population Health, Well-Being, and Equity'**, [\[PDF, 1,4 MiB\]](#). Dr. Varghese's presentation looked at life expectancy by civic association and found some significant disparities. Some areas had life expectancies as high as 83-88 years, whereas others had life expectancies as low as 78-81 years. Dr. Varghese's presentation explored the potential reasons for the disparities, these included social/institutional policies, living conditions, risk behaviors, and disease/injury.
2. Janeth Valenzuela, President of the Arlington Schools Hispanic Parents Association, provided a pre-recorded presentation (see video link below). Ms. Valenzuela indicated that they created the organization to give a voice to people in the community. She discussed the inequities being felt by immigrants to the US, and she spoke about the strategies on how to reach out to the community regarding public health, through trusted partners, non-computer methods such as paper and a cell phone app, and locations that are best for outreach and services.
3. Lesley E Daigle, CEO, Arlington Free Clinic, presented: **'Arlington Well-Being: Equity in Health'**, [\[PDF, 1,1 MiB\]](#). Ms. Daigle's presentation discussed the Arlington Free Clinic, and its mission. Lesley discussed Arlington's current state of health and wellness. A key point of her presentation was that the abundance of resources in Arlington hides the great need some individuals have, for example, upwards of 10,000 people in Arlington are ineligible for health insurance or cannot afford insurance. Lesley went on to discuss health-related lessons that were learned from the Coronavirus Pandemic and some potential solutions.

Second Panel: Equity in Arlington County Open Public Spaces

1. Jon Huntley, Senior Economist at The Wharton School of the University of Pennsylvania, presented: **'Equity in Arlington County Open Public Spaces'**, [\[PDF, 696 KiB\]](#). Mr. Huntley opened with a definition of Open Public Space (OPS), looked at race, residence type, income and related those to inequities in terms of access to tree canopy. Jon's presentation identified geographic areas within Arlington with the lowest OPS access and demographics of lowest access including lower income and multi-family elevator buildings and he discussed ways to increase "Equity" of access to open green space and trees.
2. Caroline Haynes, former County commissioner for parks, natural resources, public spaces, and biophilic design, and founding member of the Arlington Regional Master Naturalists discussed **'Biophilic Arlington and Equitable Access to Nature'**, [\[PDF, 29,0 MiB\]](#). Ms. Haynes' presentation discussed the multi-factor human connections to the natural world, including health, and how biophilic design can connect people with nature and the benefits. Caroline discussed Arlington's participation in 'Biophilic Cities Network', <https://www.biophiliccities.org/>, which advocates for expanding biophilic planning and governance to create publicly accessible urban projects which help to provide equitable access to nature. Caroline's

presentation offered some fabulous photos of biophilic projects across Arlington, and she encouraged citizen participation in County planning to help make Biophilic Arlington and equitable access to nature a reality.

3. Shruti Kuppa, Chairperson of the Northern Virginia Conservation Trust (NVCT) Board, Vice Chair for the Arlington Parks and Recreation Commission, discussed the implementation side of getting green space equity. She discussed the NVCT ([Northern Virginia Conservation Trust \(NVCT\)](#)) and focused on how a [conservation easement](#) worked, noting that easements typically require that no further development occur on the land, in exchange the landowner tax benefits.

Schools Committee

CivFed sponsored a School Board candidates' night on April 24 at Lubber Run community center. The forum included all four Democrat candidates: Chen Ling, Kathleen Clark, Larry Fishtahler, and Zuraya Tapia-Hadley. The independent candidate, Dr Vell Rives, did not attend.

The meeting opened with a discussion of the single transferable vote ranked choice format to be used, which is pretty much identical to that used in the recent County Board primary won by Susan Cunningham and Maureen Coffey, and which contrasts with the preferential block format which the Democrats used in their two-nominee caucus four years ago. Each of the candidates made statements of candidacy and then each answered a series of questions posed by our moderator (Todd Truitt) based on input he had received from CivFed and Schools Committee members, and questions from the floor. Subjects included criteria for boundary adjustment, long-term budget needs, and difficulties in recruitment.

Enhancements and Discussions on Arlington's Cultural Future

The Arlington County Arts Grants Program has successfully secured a substantial funding increase, with \$150,000 in recurring funds and a one-time grant of \$100,000, elevating the total to \$365,810. This is the first major funding boost since 2006 and comes at a critical time as the community addresses the upcoming closure of the Crystal City Underground, a key cultural space. Concerns have been raised about inadequate communication from the property managers regarding the closure, prompting a need for greater transparency.

The Arts + Culture Committee will convene on September 12 at the Museum of Contemporary Art (MoCA) - Arlington. The meeting, attended by Adam Green, Chair of the Arlington Commission for the Arts, and other notable guests, aims to listen to community concerns and engage in productive discussions about sustaining and enhancing Arlington's cultural landscape. This session is crucial for strategizing the future of local arts and addressing current community challenges.

Updates on the New Tree Canopy Study & FY2025 County Budget

Environmental Highlights of Adopted FY25 County Budget. The County Board adopted funding to enhance the natural environment and address climate change. Here are some highlights:

- Increase to one-time Climate Fund commitments from \$1 million to \$3.5 million to support enhanced cross-department coordination to accelerate achieving results and other goals.
- Increased Forestry and Landscaping programs by 19% over FY 24. Added one additional urban forester. Ongoing support for contractor tree maintenance \$750,000 (previously \$300,000) and one-time support of \$100,000 for other related expenses.
- Programs for removing invasive species received an additional \$300,000 in one-time funding (previously \$100,000 in FY 24).
- An additional \$250,000 funding for the Tree Canopy Fund operated by Ecoaction Arlington. This can only be used on private property with most previous funding coming from private developers to compensate for trees removed for development projects.
- The County Nature Centers received one-time trial funding of \$150,000 to increase staff hours from 3 days per week now to the pre-pandemic levels of 6 days per week.

No supplemental funding was allocated for other priorities cited in the new Arlington Forestry and Natural Resources Plan adopted last November including more public tree planting (Vienna had a supplemental initiative of \$250,000) or for a tree inventory and analysis tools to optimize efficiency.

County Funds New Tree Canopy Assessment. In March, the County awarded a \$53,906 contract to the Davey Resource Group with an optional additional task of \$13,000 for the study and report. The data to be used by Davey has been contracted

with the Surdex Corporation at a cost of \$40,855 for a total cost of about \$95,000 to \$108,000. According to project documents, the work has already begun with a kickoff meeting identifying actions, a timeline, data collection, and initial analysis. The final report is expected to be delivered in October of this year.

In March 2021 ACCF adopted a resolution requesting an immediate tree canopy assessment to inform drafting of the new Forestry and Natural Resources Plan. The County declined but citizens moved forward funding an independent study by nationally recognized experts resulting in the 2023 [Urban Tree Canopy Assessment of Arlington County Virginia : An Analysis of Forest Cover and Benefits](#). The study provided land cover, tree canopy, heat island, neighborhood maps, public meetings, and reports for less than 20% of the cost of the new assessment. Noteworthy in tight budget times.

Housing Committee Meeting May 16 at 6:30pm - Taxes and tracking housing needs

The Housing Committee will discuss key resolutions on taxes and better tracking of housing needs, zoning, and delivery of housing units. In light of the recent adoption of a significant tax increase, the committee will discuss the impact on housing. The draft housing tracking resolution focuses on calling for tracking that would show housing potential and goals and track progress toward goals.

In June we hope to host the Housing Association of Nonprofit Developers (HAND) which is rescheduled from March. They will track an innovative new housing production tool that will be adopted by the Metropolitan Washington Council of Governments (MWCOG) for the Greater DMV area. HAND is a nonprofit membership collective working across the private, public, and social sectors to collaborate in the production and preservation of affordable housing in the Capital Region.

Library Co-creation Workshop

Attendees: Library staff, Accenture staff, County staff, civic leaders by invitation

Cory Giacobbe attended the Library Co-Creation Workshop as a rep for CivFed. A year ago, County Manager Mark Schwartz called for libraries to engage the public in envisioning the future of our libraries. The purpose of the 3-hour workshop was to brainstorm a vision for the library of the future, what community needs it should meet and how it should meet them. Ten pre-formed groups completed various facilitator-led tasks to brainstorm, envision, refine and prioritize elements of a future Arlington library. Groups were given opportunities to collaborate, define and expand on their vision of the library of the future.

Ideas explored included Library as Town Square, Flexible Library Spaces for Community Generated Needs, Welcoming Areas for Community Gathering, Latest Technology for Professional Development, and many more.

Many participants wished for longer hours, more child and youth activities, more opportunities for creative and collaborative endeavors and more programs and services for residents with special needs. The overwhelming sense of the workshop was that Arlington residents crave more time and space for coming together for relaxation, creation and recreation. The term used for this type of space was “The Third Place”. After Home (first) and Workplace (second), we crave a community meeting place, that was historically fulfilled by the town square, the pub, the plaza, the coffeehouse or the marketplace. Planners and visionaries are looking to the public libraries to fill this function in society.

Accenture staff collected all brainstorming materials (sticky notes, vision collages, implementation schema, etc.) and will process the community input, send it back out to the participants and report back to the County Library leadership. Based on the ideas generated on the workshop, as well as interviews and site visits, a digital survey created by Accenture will be distributed in early May. Flyers with a QR code will be displayed at all library locations.

Gun Buyback Intended for Early June If Sufficient Funds Are Raised

Arlington PD in conjunction with other County offices intend to hold a gun buyback in early June. At a buyback, unwanted guns are exchanged anonymously for gift cards in an amount appropriate for the type of gun relinquished. Guns are received, dismantled and destroyed. \$25,000 must be raised by May 1 to defer the cost of the gift cards and make this a viable event. Since funding was not built into the county budget it must be raised by concerned citizens.
