# **President's Message**

I hope you had a wonderful holiday season and wish you health and happiness for 2026. We will have lots of issues to tackle in the new year and working together we can achieve the best possible outcome for Arlington.

**December Meeting.** We had a good discussion with County Manager Mark Schwartz, who talked about some of the issues the County is facing. It will be a challenging budget year, both for the operating budget and the capital improvement plan. Maintaining the social safety net as Federal programs shrink will continue to consume time and resources. On the regulatory front, work continues on the comprehensive plan update, master transportation plan, and lot coverage calculations. There will also be activity on adaptive reuse projects as the County works with developers to reduce the oversupply of commercial office space.

**Form of Government (FoG).** One of the last items the County Board considered in 2025 was whether or not to establish a task force to examine our form of government, something CivFed has supported through the work of its Task Force in Governance and Election Reform (TiGER). The decision was to postpone establishing a task force until July 2026 but to put in place a preliminary analysis framework. **See Dave Schutz's article** in this newsletter with more details.

**January Meeting.** One of the people who played a key role in the decision to move forward with an analysis and eventual July decision on a task force was **County Board member Julius D. "JD" Spain, Sr.** Since our membership has followed this issue closely and done a lot of the initial groundwork through TiGER, we thought it would be good to sit down with JD and talk about how he sees the process playing out during 2026. JD will also take general questions from the members.

**Police Chief Andy Penn** will also join the meeting for one of his regular updates. I've asked the Chief to give us an update on how the holiday season went and what kind of trends he is seeing across the County and region.

Arlington Neighborhood News Exchange (ANNE). One of the best CivFed products, in addition to serving as a non-partisan safe space for discussions, is the exchange of information across the County. Many of our member organizations publish newsletters in various formats, and we want to support the sharing of articles among them. CivFed hosts a resource that allows neighborhood newsletter editors and webmasters to share and swap articles. Hon. Julius D. 'JD' Spain, Sr. Member, Arlington County Board

Hon. Julius D. "JD" Spain, Sr. was elected to the Arlington County Board in November 2024, marking the first general election in Arlington conducted using ranked choice voting. A retired United States Marine Corps veteran, Spain served 26 years, including combat deployment to Iraq, a diplomatic assignment in Brussels, and senior advisory roles on Capitol Hill. He retired as Master Gunnery Sergeant E9 and received the Legion of Merit for exceptional leadership and service.

In the private sector, Spain served as a senior business leader at a management consulting firm, leading initiatives across government, academia, and industry. He is an active member of George Mason University's President's Innovation Council and Inclusive Excellence Council.

Spain's civic engagement includes service on Arlington's Civil Service Commission, two terms as President of the NAACP Arlington Branch, tenure as Regional Vice President for Virginia, and delegate to Arlington County Civic Federation. Under his leadership, the NAACP Arlington Branch received the FBI Washington Field Office Community Leadership Award, the James B. Hunter Human Rights Award, and the National Thalheimer Award. Spain is also a Thirty Third Degree Scottish Rite Freemason, an honorary distinction recognizing extraordinary service and leadership within Freemasonry. He has served as a former elected Grand Lodge Officer of Prince Hall Freemasons in Virginia, including on the Grand Lodge Board of Directors, and as leader of Arlington Lodge #58. He is also a Shriner.

Spain holds a Bachelor of Science in Political Science from the University of Maryland, advanced legislative credentials from Georgetown University, and is a graduate of George Mason University's Chief Diversity, Equity, and Inclusion Officer Executive Development Program. A longtime Arlington resident, Spain and his wife of 33 years have lived in the historic Butler- Holmes subdivision of the Penrose community since 2009. They are the proud parents of three adult children, all graduates of Arlington Public Schools, and devoted grandparents to their granddaughter. Their family's deep roots in community affairs continue to inspire Spain's dedication to serve Arlington with integrity, fairness, and vision.

In the December County Board meeting, Board member Maureen Coffey noted that she had heard complaints that the Board had too many five to zero votes on issues which were contentious and noted that FoG was providing the contention complainants were seeking. We are doing our best!

**In the November 15 Regular County Board Meeting**, members Spain and de Ferranti introduced a motion for a draft charter for a FoG advisory panel.

The panel's purpose was described as: to evaluate whether the existing at-large election system, with five board members serving staggered terms, remains effective amid Arlington's evolution.

Key areas of inquiry for the advisory panel were to include:

- whether to expand the board's size
- to shift to district-based or hybrid representation
- to separately elect the board chair
- adjust election cycles
- and/or further formalize ranked-choice voting.

Public testimony was both pro and con, as was discussion by the Board. Matt de Ferranti and Julius "JD" Spain Sr., advocated for advancing the process, emphasizing the need for "due diligence" and viewing it as an opportunity to empower Arlingtonians through structured dialogue. De Ferranti argued against delaying, stating, "We could get to December and decide to defer, but deciding now... is not where I am." Takis Karantonis was moderately favorable, and Susan Cunningham and Maureen Coffey expressed reservations, worried about the cost, called for clearer problem definitions and warned that ambiguous goals could lead to ineffective outcomes. The meeting concluded with a 3-0 vote (Coffey and Cunningham abstaining) to extend discussions to December, soliciting community feedback via an online form by December 1 noon. Takis Karantonis supported exploration but cautioned on specifics like districts, which he feared could foster "balkanization." During the following month, the Board received a large number of comments both pro- and anti- panel initiation. Number two and three contain the public comments, all four are worth your interest.

**December 17 discussion:** de Ferranti highlighted challenges like affordable housing and equity, rejecting the "if it ain't broke, don't fix it" mindset; Spain stressed historical exclusion of minorities baked into the system and the value of hybrid models; Karantonis emphasized efficiency amid inequalities. Coffey and Cunningham urged prioritizing core issues like budgets during economic uncertainty, with Cunningham noting unequal public engagement opportunities for vulnerable groups. There was a very impressive turnout of former electeds — many of whom had submitted testimony in which they voiced skepticism on timing and necessity (Former elected officials raise concerns about moving too fast on Arlington governance changes | ARLnow.com). Most of the public commenters largely favored proceeding, with organizations like the NAACP and Arlington Civic Federation advocating for equity-focused panels, transparency, and inclusive reforms like multi-seat ranked-choice voting. League of Women Voters in November expressed support for the idea of examining our FoG and wanted the charge improved to make a better outcome more likely.

**The December 17 outcome** was a compromise motion by Spain, seconded by Cunningham, to initiate preparatory efforts immediately but to defer the decision on whether to empanel the advisory group until summer. Preparatory work from the County Attorney will include legal reviews of Virginia laws controlling FoG in Arlington and peer jurisdictions, partnering with non-partisan researchers for historical analysis, engaging the School and Electoral Boards, identifying funding by March, and reporting findings in July 2026. Spain and Cunningham were designated as liaisons, which your author hopes will engender support (or at least acquiescence) for going forward this summer.

This study, if the County does embark on it, is probably our best chance in the last nine decades to adjust our FoG for better representation and responsiveness. Residents are encouraged to stay involved as the process unfolds, ensuring the final recommendations reflect the community's diverse needs.

# **Volunteers Needed to Review Grant Proposals**

The County has put out a call for focus group participants to review proposals submitted by local non-profits for the current Opportunities Grant cycle that closes on January 13. The County expects to award approximately \$1.25m to support nonprofits in implementing programs or projects which will create opportunities for Arlington residents to thrive, while reducing, eliminating, or preventing inequities in direct response to demonstrate community or human services needs. Focus group participants will review executive summaries of each proposal and prioritize the proposals based on the most urgent community needs and largest impact. Participants will join two focus group meetings of about 2-3 hours each. The grants will then be approved by the County Board, expected at the April meeting.

# **FY2027 Budget Guidance**

The Arlington County Board issued <u>budget guidance</u> to the County Manager in December, ahead of preparations for the fiscal year (FY) 2027 budget. The Board directed the Manager to provide budget options for the Board's consideration that include, but are not limited to:

- Reductions and Efficiencies;
- Revenue Increases;
- Restructuring social safety net programs;
- Recommendations for the fiscally sustainable use of one-time funding in the stabilization fund and other contingency funds over a multi-year period;
- Funding WMATA at levels consistent with potential solutions included in the Council of Government/DMVMoves adopted resolution; and
- Preparing analysis that will lead to adoption of Memoranda of Understanding between the County Board and other Arlington Constitutional Officials.

Arlington had one of its smallest-ever budget surpluses (just \$1.8 million) at the end of FY2025.

In November, the County Manager presented information on the closeout of FY2025, which ended on June 30, 2025, and provided the County Board with an update on FY2026 (the current fiscal year) as well as conditions related to the planning of FY2027:

# Virginia Hospital Center Hazel Auditorium Parking and Access Instructions for General Membership Meetings

Reminder: Parking passes will be provided. Meetings are held in the 'Conference Center' depicted on the map below.

The VHC Director of Security has advised CivFed that we should begin to park in Parking Garage C (map below). You can then walk across to the Oncology entrance and gain admittance until 8 p.m. **After the meeting, you MUST EXIT via the Women's and Infant lobby.** 

**ENTER (until 8 p.m.):** Zone C Ground floor Oncology entrance (only open until 8 pm, Monday-Friday)

- Sign into the visitor kiosks (need driver's license each time)
- Get visitor sticker and wear at all times when inside the hospital
- Take a right at the double doors by the visitor kiosks
- Take a right at the single door
- Go to elevators and take to lobby floor
- Exit elevators and go left to hall directly behind welcome desk in lobby
- Take a left at the single door and continue down the hall toward a set of double doors
- · Go through double doors and go right
- Conference center auditorium is directly ahead

**ENTER or EXIT (24/7)**: Zone C first floor Women's and Infant lobby entrance (please use this entrance to exit after 8 pm, open 24/7):

- Sign into the visitor kiosks (need driver's license each time)
- Get visitor sticker and wear at all times when inside the hospital
- Walk to hall directly behind the welcome desk in the lobby
- Take a left at the single door and continue down the hall toward a set of double doors
- Go through double doors and go right
- Conference center auditorium is directly ahead
