GENERAL MEMBERSHIP MEETING MINUTES, TUESDAY 10 MARCH 2026

MEETING: Arlington County Civic Federation, General Membership Meeting, 3/10/2026 7:00 – 9:00
Hybrid meeting held in-person at the VHC Hazel Auditorium and virtually via Zoom, called via email invitation, web notification, and Facebook post.

Would the School Board support a 1% sales tax for school construction? Can we get Solar panels mounted on the schools? Why do Montessori schools get more money per head than other schools? Is the Board considering increasing the size of the Board? What is the spacing of the Swanson and Thomas Jefferson construction projects? What is the mid-range option on the TJ construction project? Has APS seen any impacts from Federal Immigration policy? Have you seen a decline in new English learners? Is the County asking for private money to help with the Swanson and TJ construction? Why did Patrick Henry have to be demolished (it's fairly new)? What could APS and the County have done better about handling the aftermath of the big snow storm?
