School Board Q & A Rules

The Executive Committee has decided on question and answer "rules" for the Arlington School Board program. These rules will be in effect during the planned 35 minute questions and answer period set forth in the agenda. The purpose of these rules is to maximize participation by the delegates and alternates. Even with the rules below, given the planned time, it is most likely that only 10 to 12 questions can be addressed. These "rules" are as follows:

- Participation Only Delegates or Alternates will be permitted to ask questions of the Arlington School Board at the December 5th meeting.
- 2. Questions will be limited to a maximum of 30 seconds only. Delegates or Alternates should minimize comments and make sure they pose a "single" question. Compound and follow-up questions by the same individual will not be allowed.
- 3. The School Board response(s) to any individual question will be limited to a maximum of three (3) minutes.
- 4. Timing will be rigidly enforced the moderator will cut-off either questions or responses exceeding the timeframes set forth above.

- Appointments None during this period
- 2007 Banquet Program The Executive Committee has started work on the 2007 annual banquet. We have determined the location for this year. The Committee led by its able Vice Chair, Stan Karson is hard at work on identifying and getting a commitment from the keynote speaker. During the December meeting, the selection will

be made of the awards committee for the 2007 program. Stay tuned for details as they develop.

- Veterans Day 2006 As in past years, the ACCF presented a wreath at the ceremony at the memorial located in Clarendon Central Park. - Elder Readiness Task Force We have had communication from the Chairman of the Elder Readiness Task Force a group appointed by the County Board. Initial draft reports have been received. As far as we know, no ACCF member is on this group. The Executive Committee decided that further discussions with the Chairman at our December 11th Executive Committee meeting was the next logical step. Determination of any presentation to the ACCF members and, response to what are very broad recommendations will be considered.
- FYI Quarterly meeting with Board Chair We have been fortunate in having meetings at least quarterly with the County Board Chair. This schedule was established early this year by Patrick Smaldore and has continued. We are hopeful we can adhere to this type of meeting in the future. Such meetings enable us to address activities during that period. We also follow up on any unresolved resolutions or issue areas, including appointments. School Board Posed Questions

By Executive Committee

As part of the invitation to the Arlington County School Board, the Executive Committee submitted a set of policy related questions to the Board. The focus on policy is because that is what the Board addresses – versus the operational activities addressed by the Superintendent and staff. We expect these policy oriented questions will be addressed during the School Board presentation. The "Issue" areas followed by the specific policy oriented questions are as follows:

1. Issue Area - Achievement Gap -schools

Question: What is the School Board doing to raise achievement for schools that consistently don't make AYP? What were last year's strategies and results (for specific schools) compared to the year before? What are strategies and goals or expected results for this year?

2. Issue Area - Achievement Gap - populations

Question: What initiatives supporting the four critical variables identified by the School Board (expectation, quality of teachers, access to opportunity, and parental/community support) have changed since your visit last December? Which are the most important in improving the academic performance of minority students?

3. Issue Area - Quality and Cost Comparisons to VA and Nation

Question: Arlington taxpayers provide funding that meets or exceeds the levels of other NVA communities and similar communities nationally yet quality measures like SAT scores and the numbers gaining entrance to competitive VA schools doesn't seem to be competitive. Please provide relevant comparisons of cost and quality and indicate what the Board is doing to be accountable for delivering a competitive cost/benefit for students and taxpayers.

4. Issue Area - Evaluation and accountability

Question: How do results of annual priorities and results of evaluations impact School Board strategies and programs?

- a) Which results of last school year's annual priorities surprised you and which ones do you find unsettling and/or most significant?
- b) What significant findings and changes have been made as a result of the 5 years of evaluations by the Planning and Evaluation Department and the Accountability and Evaluation Committee?

5. Issue Area - Policy & scope of students who are not legally in US

Question: Please address the policy and scope of APS students whose parents are not legally in this country. ... continued

6. Issue Area - Community Engagement

Question: What should the community expect from the School Board in how they address and answer both policy questions and questions relating to admin accountability?

Your Home - Workshop

The following is from Chikwe Njoku who is the Neighborhood Program Coordinator with CPHD (Community Planning, Housing and, Development) of Arlington County. This workshop was mentioned briefly at the November ACCF meeting.

Chikwe Njoku would like to take this opportunity to invite your participation in a new project that CHPD is developing that they hope will be useful and informative for the residents of Arlington County. A series of interactive workshops is being prepared that are designed to provide more insight into the programs and services that are provided by the various County Departments to the community. The purpose of this program is to provide residents with an opportunity to meet, to ask questions and to learn more about County programs, processes, and services. Additionally, residents will be able to identify opportunities where they can partner with the County.

They are particularly interested in members of the Civic Federation attending their "Pilot" Workshop that will include representatives from Code Enforcement, Inspection Services, and the Housing Division. The subject of this workshop is "Your Home" and each Division will conduct a brief presentation and an overview of their services as it relates to "Your Home" and cover such topics as: building permit process, when a permit is needed, what constitutes a code violation, types of violations, the violation process, how to report a violation, home maintenance tips, tenant/landlord services just to name of few of the topics. Afterwards, participants will have the opportunity to ask questions of these representatives regarding their programs and services. The goal is to get 15 to 20 members of the Civic Federation who are interested in participating in this workshop and who will give feedback at the end of the session.

Workshop Particulars:

At this workshop you will meet several county staff from the Department of Community Planning Housing and Development. The following Divisions will make presentations:

<u>Inspection Services</u> – The office of Inspection Services issues building permits to ensure that all building construction and related services are carried out according to the Virginia Unified Statewide Building Code to ensure the health and safety of residents and users. You will learn when a permit is required, the process involved in getting a permit and general information about other related services provided by this office.

<u>Code Enforcement</u> – The Arlington County Office of Community Code Enforcement responds to thousands of inquiries about possible violations of Virginia Commonwealth Law and Arlington County's Local Ordinances. In this illustrative presentation you will get answers to these frequently asked questions: How do I make a formal complaint? What is a violation? What should I do if I receive a notice of violation and what is the enforcement process?

<u>Housing Services</u> - Participants will get information on their rights and responsibilities as a tenant and how to build good relationships with their landlords. For home owners, the services include information on "hands on" workshops that are offered concerning property maintenance and home improvement; and for the potential homeowner, information on the County's homeownership programs.
