What is the Elder Readiness Plan? As baby boomers age, the number of elders in Arlington will more than double. The proposed Elder Readiness Plan is a blueprint for an inclusive, livable community that will be ready to meet the increased needs of the elder population expected over the next 25 years.

The plan recommendations address four major areas: housing, transportation, supportive services/health care, and community involvement. The plan lists goals, strategies, outcome measures, responsible parties and timing.

Zoning Change Proposal

By Planning and Zoning Committee

At the February 6th meeting, the Civic Federation approved a resolution following a presentation and discussion led by the Planning and Zoning Committee. ACCF voted to suspend rules since the Board was scheduled to consider the changes on February 24, which was before the next Federation meeting. The resolution:

Proposed Zoning Changes (Amendments to Chapter 27A of the Zoning Ordinance, "C-R" Commercial Redevelopment District)

Whereas the County Board advertised certain proposed changes to the C-R zoning district on January 27, 2007, and intends to vote on them on February 24, 2007;

BE IT RESOLVED THAT The Arlington County Civic Federation recommends that the County Board defer consideration of the proposed zoning changes until at least the April County Board meeting so that the substance of the changes can be explained to the Civic Federation and to interested civic associations throughout the County.

Since then, the Planning Commission met and considered those zoning changes at its February 12th meeting. For some of the same reasons ACCF discussed, the Planning Commission voted 7 to 3 to request a deferral until April. On February 15th both the Housing and Transportation Commissions voted to support the changes.

If the County Board at its February 24th (or carryover) meeting supports a deferral (as recommended by ACCF and the Planning Commission), we will provide time for a Planning and Zoning Committee program in support of our resolution's provision, namely – "so that the substance of the changes can be explained to the Civic Federation". Obviously, if the County Board takes other action at its February meeting, this "tentative" agenda item will not occur.
