State Delegation Program

The State Delegation Program is always a favorite. We have invited our State Elected Representatives (Alphabetically):

At time of publication Patricia S. Ticer (30th Senate), expressed regrets due to a previous commitment.

Program Structure – We will first hear from each Delegate on his/her areas of concern, focus and, accomplishments. Each will also address one specific issue as part of the opening remarks (*see below*). Finally, the panel will entertain questions from ACCF Delegates or Alternates in two ways as described below.

Specific Issues - The Legislation Committee provided the State Delegation six specific issues to be **briefly** addressed during the remarks portion. Attending Delegates will select from these and determine among themselves which "one" each will address.

The material sent to all the above Delegation members is as follows and defines the program details:

Opening Remarks -- 25 minutes (i.e., 5 minutes per Arlington State Delegation Member, assuming five Members attend). Five "issues" have been selected by the executive committee for the opening remarks portion of the meeting. Below are the five "issues". Please use most of the 5 minutes to discuss one of the five "issues." However, if there are any other issues you believe important, use a portion of the time to discuss that issue.

- State's financial situation, FY 2010-2011 biennial budget, and items governor vetoed. Please discuss all three items.
- 2. Unemployment compensation benefits. The bill (?SB 1495?) passed the Senate unanimously and the House with a large bipartisan vote. However, the reconvened session saw a flurry of activity regarding the governor's amendments, not to mention discussion in the press. Please discuss the movement of legislation, but especially the issues for rejecting the governor's amendments.
- 3. <u>Transportation</u>. Given Virginia's current fiscal outlook, will you be advocating any new transportation initiatives during the 2010 session, and if so, what would be your proposed funding source(s) for those initiatives?
- 4. Smoking ban in restaurants. This item achieved a supermajority (32-8) in Federation voting. Bills (SB 1105 and HB 1703) were amended in the House and the Senate bill was even amended in conference. Please discuss important issues as bills moved through the legislative process.
- 5. Higher education, K-12, special education, and early childhood education. For the next legislative session, please identify your top issue in four areas (higher education, k-12 education, special education, and early childhood education) where Civic Federation delegates and their neighborhood associations can get involved with your work and make a positive impact at the state level.*
- 6. **Budget transparency/searchable database. This item achieved a supermajority (35-2-3) in Federation balloting. Bills (SB 936 and HB 2285) passed unanimously. Please discuss the bills, their movement through both houses, what information will be available, and when will the information be available.

"Filtered Questions" -- 15 minutes (Federation delegates will submit written questions when they arrive at the meeting. The questions will be reviewed by a three-member Federation panel and sorted into two to four questions that will be posed to State Delegation).

Floor Questions from Federation delegates -- 15 minutes.

<u>"Round Robin" -- 5 minutes</u> (opportunity for each Arlington State Delegation Member to comment on any topic not discussed previously.

Public Service IT Resolution Report to Membership

The Public Services Committee received a draft motion relating to combining common county and schools communication and information technology systems, and is recommending that it be adopted at the ACCF May 5 General Membership meeting.

S/ Mike Kerley, Chair (Arlington Forest), Robert Atkins (Arlington County Taxpayers Association), Stan Karson (Radnor/Ft. Myer Heights), Amy Levin (Aurora Highlands), Larry Mayer (Lyon Park), Jim Pebley (Waycroft-Woodlawn), Jackie Snelling (Lyon Village), and Eileen Williams (League of Women Voters)

The motion was introduced by Joe Pelton, delegate from Chain Bridge Forest and Chair of the Arlington County Information Technology Advisory Commission, at the April 7, 2009 Civic Federation meeting. The committee studied the motion under the portion of its jurisdiction that goes to "organization, administration, and the procedures of local government."

The issue the motion raises is should we ask our county and school governments to get together at a leadership level to figure out if they can save money and improve service by working together. The committee found that, while the issue and its potential opportunity to discover savings has been extensively considered by county and school board members individually, relevant advisory commissions, and county and schools senior IT staff, the question to undertake a proper study and implement necessary actions needs to be considered at the very top levels – i.e. by both Boards and the County Manager and School Superintendent.

In an effort to establish and verify facts and fully appreciate the issue's background, committee members extensively discussed the issue (in person, over the telephone, and by email) among themselves, with senior county and school staff, the chair and a commissioner of the Information Technology Advisory Commission. In addition, the committee reviewed relevant state policy and county and school documents dating to 2001.

The committee decided not to broaden the motion to include reviewing the revenue sharing agreement or calling for specific actions or solutions. Rather, the motion recommended by the committee simply asks the county board, county manager, school board, and school superintendent to get together to determine if there would be cost savings and service improvements from combining common communication and information technology services.

Resolution Wording is below:

WHEREAS, cost savings and service improvements could result from the county government and school system combining common communication and information technology services; and

WHEREAS, economy of scale has proven successful between the county government and the constitutional offices; and

WHEREAS, potential cost savings and service improvements could make a positive, substantial impact to the 2011 budget.

THEREFORE BE IT RESOLVED THAT, the Arlington County Civic Federation calls on the Arlington, Virginia County Board, County Manager, School Board, and School Superintendent to meet to determine if there would be cost savings and service improvements from combining common communication and information technology services and if so to implement necessary actions as soon as possible.
