Emergency Preparedness

Christopher Essig, Chair of the Arlington County Emergency Preparedness Advisory Commission briefed Civic Federation delegates on the mission of the new commission. The commission's mission is to be a community forum and coordinate efforts to make Arlington a safe, wellprepared and resilient place to live, work, and visit. Mr. Essig and Vice Chair Mike Signer asked the Civic Federation for input on plans for involving the community in emergency preparedness including a potential public forum, exercises, and training and motivating individuals and neighborhoods. As a way of getting input, a quick survey was given to complete to indicate the important threats, priorities and member organizations' interest in educational presentations.

Results from surveys collected during the program name a range of hazards and priorities for preparedness planning and indicate that member many neighborhoods would be interested in presentations to improve individual and neighborhood knowledge and participation in preparing for emergencies.

Threats listed as important included:

- Disruptions to power, water, gas and communications from multiple causes,
- Metro accidents and high-rise fires, and
- Terrorism including attacks on Metro, cyber, and utilities.

Preparedness planning priorities included:

- Public alerts and warnings,
- Evacuation or reaching shelter for people without cars and people with disabilities,
- Neighborhood preparation to help neighbors and organizational prep for sheltering like supplies of water for schools, churches, employers,
- Education and guidance for evacuation and shelter re community plans (go bag demos, shelter in place guidance, designated shelters),
- Broadband and wireless communication protection and restoration plans,
- Access to medical help, and
- Education for school age residents.

The Legislation Committee met on Monday, November 22, 2010 where it heard a presentation from Commissioner of the Revenue Ingrid Morroy and Deputy Commissioner of the Revenue Ann Bisson. The Committee had had referred to it a motion offered by Committee Chairman Peter Owen at the November 9, 2010, Civic Federation meeting relating to legislation regarding local tax administration. After discussion, the Committee voted 8-0 to recommend that the Federation adopt a motion for resolution in favor of legislation to allow local revenue collectors (such as Arlington's Commissioner of the Revenue) to administer specified registration and tax

assessment functions currently conducted by the State of Virginia. The Committee Chairman was directed to finalize the wording of the motion in a manner consistent with the deliberations at the meeting. The motion is listed on page 5 in Unfinished Business section of this newsletter. Committee member Barbara Olivere was authorized to present the Committee's report to the Federation. Present for the meeting were: Peter Owen (chair), Barbara Olivere, Robert Atkins, Jerry Auten, Tom Connally, Peg Hogan, Conor Marshall, and Stuart Raphael.

The committee is preparing an informational program for the December 7, 2010, Civic Federation meeting with guest speaker Patrick Murphy, Superintendent of Arlington Public Schools.

On October 11, 2010, Patrick Spann (Bellevue Forest Citizens' Association) was appointed to represent the Civic Federation and serve as a Board Member for the Arlington County Scholarship Fund for Teachers. The Fund awards scholarships to students who are members of the June graduating class of an accredited public high school located in Arlington County and who plan a career in education. The Civic Federation has been a sponsor of the fund since it was founded in 1955.

On November 9, 2010, the Arlington County School Board appointed Kenneth Friedli (Maywood Civic Association) to represent the Civic Federation and serve on the Arlington Public Schools Budget Advisory Council. The role of the council includes:

- Making recommendations on policies and practices related to the presentation and preparation of the operating budget and the financial management of the school system;
- Making recommendations to the School Board on budget priorities before the Board gives its annual budget direction to the Superintendent and at other times as appropriate;
- Advising on the degree to which the Superintendent's Proposed Budget supports best fiscal practices and the School Board's priorities;
- Assisting in educating the community about the budgeting process and the contents of each year's budget;
- Providing, upon the Board's request, study and recommendations on special topics or issues;
- Presenting an annual written report of the Council's work as part of the School Board's annual budget process. The report may raise issues and concerns that the Council has related to the budget, and
- Collaborating as appropriate with the Arlington Public Schools Advisory Council on Instruction.

Unfinished Business

Tax Administration Motion

On December 7, 2010, Civic Federation member delegates will hear, discuss, and consider a recommendation from the Civic Federation Legislation Committee regarding Tax Administration. This item will include a presentation by Commissioner of Revenue Ingrid Morroy and an opportunity for delegates to ask questions. A member delegate vote is anticipated:

<u>Whereas</u> an efficient, accurate and taxpayer-friendly tax assessment, collection and accounting system is in the interest of Arlingtonians and Virginians,

<u>Whereas</u>, the Commissioners of the Revenue Association of Virginia has proposed certain changes to Virginia tax administration to create more efficient, accurate and customer friendly tax assessment and collections,

<u>Whereas</u>, the Association's proposals would allow local tax administrators to provide "one-stop" services for certain local businesses, and would be able to more promptly and accurately assess sales and other taxes from certain local businesses, and

<u>Whereas</u>, "local" tax administration addressed by the Association's proposals would in Arlington County be administered by the office of the Commissioner of Revenue,

<u>Be it therefore Resolved</u>, That the Arlington County Civic Federation supports legislation allowing local registration for state and local business taxes, local monitoring of the local option portion of the state sales and use tax, local/state tax audit partnership for the meals tax, and local registration and monitoring of businesses that are subject to the licensing laws of the Department of Professional and Occupational Regulation.
