Emergency Preparedness

On December 14, 2010, the first annual report of the Arlington County Emergency Preparedness Advisory Commission was submitted to the Arlington County Board by commission Chairman Christopher Essig. In his remarks, Chairman Essig reported that public outreach will be a priority and that, while much work remains, the Commission has "started a dialogue with the Arlington County Civic Federation." The report includes accomplishments from this year such as the focus on the Emergency Management and public safety budgets and a preview of commission priorities for the coming year. The Commission was created in May 2009 in recognition that preparedness efforts must be collaborative and when, confronted with a crisis, the community must respond as a system in order to ensure the greatest service to those in need.

The committee has transmitted to Arlington's state legislators the Tax Administration motion that Civic Federation member delegates adopted as a resolution on December 7, 2010:

<u>Whereas</u>, the Commissioners of the Revenue Association of Virginia has proposed certain changes to Virginia tax administration to create more efficient, accurate and customer friendly tax assessment and collections,

<u>Whereas</u>, the Association's proposals would allow local tax administrators to provide "one-stop" services for certain local businesses, and would be able to more promptly and accurately assess sales and other taxes from certain local businesses, and

<u>Whereas</u>, "local" tax administration addressed by the Association's proposals would in Arlington County be administered by the office of the Commissioner of Revenue,

<u>Be it therefore Resolved</u>, That the Arlington County Civic Federation supports legislation allowing local registration for state and local business taxes, local monitoring of the local option portion of the state sales and use tax, local/state tax audit partnership for the meals tax, and local registration and monitoring of businesses that are subject to the licensing laws of the Department of Professional and Occupational Regulation.

The committee is preparing the Legislative Delegation program for the January 4, 2011, Civic Federation meeting.

The committee has not received, other than the tax administration issue, federal or state legislative issues to organize in a supplement for member delegates to consider adding to the Civic Federation legislative packages that have been adopted in past years. In preparation for the January 4, 2011, Civic Federation program about snow removal and winter storms, the committee is reaching out to neighborhood presidents to find out what information would be important for them to hear during the discussion. The program will focus on what Arlington residents may expect this winter regarding Arlington's new sidewalk snow removal ordinance, Arlington's snow clearing operations, and countywide electric power delivery.

Information about Arlington County's comprehensive snow removal plans and priorities are on the Arlington County website (www.arlingtonva.us/portals/topics/ TopicsWeatherWinter.aspx).

A new Arlington County ordinance requires property owners to remove snow and ice from public sidewalks adjacent to their property within 24 hours after the snow stops falling when accumulations are less than 6 inches, and within 36 hours when 6 or more inches of snow accumulate.

To support the many generous snow cleanup neighborhood volunteers, Arlington County maintains 25 snowblowers to lend to civic associations or community groups to assist with clearing routes to schools and Metro stops, or to clear the walkways of neighbors with disabilities or special needs. The snow blowers are loaned to groups according to the size and importance of the area they can support. Training is provided. All snowblowers have been allocated for the 2010-2011 snow season. Interested groups may get on a list to be contacted for consideration for next season's effort.

The committee is studying a portion of the Arlington County policy and practice of controlled home burning. This is due to concerns expressed by Civic Federation member organizations that burned homes could be left standing for an extended time.
