# Election of Civic Federation Nominating Committee

According to the Bylaws of the Civic Federation a Nominating Committee of five member delegates will be elected at the April 5, 2011, general meeting. It will be the duty of this committee to nominate at least one candidate for each office and at least five members to serve on the executive Committee. The nominees for office and for the Executive Committee will be Civic Federation delegates or alternate delegates. The Nominating Committee will submit its report in writing to all the member delegates through the newsletter, or by other appropriate means, and will report at the June 7, 2011, general meeting, where member delegates will elect officers and members of the Executive Committee.

# Special Rule for Budget and Tax Rate program

Civic Federation member delegates will hear reports from the Revenues and Expenditures Committee and Schools Committee about their studies of the budgets proposed by the County Manager and Superintendent. The reports will be combined for discussion by Civic Federation member delegates but voted on separately. Following past precedent and due to the complexity and length of the budget proposals, the separate reports will not be subject to motions to amend and after discussion will be put to Civic Federation member delegates for two up or down votes to adopt the reports as a Civic Federation resolution. Additionally, the committees may provide separate items for member delegate discussion and vote.

A member delegates vote is anticipated after hearing and discussing the special rule.

# Planning and Zoning

The committee is preparing to lead an informational program at the May 3, 2011, Civic Federation meeting about the Arlington County sign ordinance and the plan to update it (http://tinyurl.com/SignOrdinancePlan).

The committee presented an interim report on neighborhood edge re-development at the March 1, 2011, Civic Federation meeting (www.civfed.org/presedgeredevel1103.pdf).

Community leaders should know the following about each property in their neighborhood civic association:

- The General Land Use Plan category as this may represent how the property will be developed in the future;
- The Zoning keeping in mind that you can't tell the Zoning by looking at what is there now, as a single-family house may be on a site with apartment or commercial zoning;
- Property ownership so you can see if properties have been consolidated;
- Any special plans that apply, such as Sector Plans and Neighborhood Conservation Plans;
- Any areas that staff considers to be unplanned;
- Where the GLUP and Zoning conflict which may or may not be important;
- Historic property designations;
- Approved but unbuilt Site Plans; and
- Areas designated as transfer of density receiving sites.

When a re-development project is proposed, it may be helpful to understand property encumbrances such as:

- Sidewalk and road easements; and
- Conservation or water easements (these are hard to determine except on a property-by-property basis by researching Circuit Court records).

The motion for resolution, as introducted by Mr. Hilz and referred to the Executive Committee, is listed below:


Due to administrative error, one section of the current boundary of the Fairlington Citizens Association is incorrectly drawn and mistakenly includes residents that do not live in Fairlington.

*The Bylaws of the Fairlington Citizens Association state that membership is limited*  to Fairlington residents and that its purpose is to unite the influence and endeavors of those residents.

Article II-Purpose, Section 1 states, "The purpose of this organization shall be to unite the influence and endeavors of the Fairlington community by promoting, through purposeful and constructive cooperation, activities to make Arlington, and specifically Fairlington, a better community in which to live."

Article III-Membership, Section 1 states, "Any resident and/or owner of Fairlington who is interested in the objectives of this organization shall be eligible for membership."

Accordingly, the Executive Board of the Fairlington Citizens Association requests that the boundary of the Fairlington Citizens Association be amended as indicated on the attached map (see below).
