Human Services Commission Report**

Providing Input on Budget Process . . .

At our October 3 meeting, Ed McWethy, Chairman of ACCF's Revenue and Expenditures Committee, will present for delegates' consideration his Committee's recommendations on how the Proposed FY97 County Budget should be drafted.

Because the process of drafting, submission, review and adoption of the County Budget is complex and, at times, fast-moving, the Committee believes that the best chance to influence the process and outcome is to provide the Civic Federation's position to the County Manager and Board as soon as possible.

The Committee's Resolution contains recommendations on Budget policy, guidelines and presentation. After the Committee's report and time for questions from the floor, the Resolution will be presented for debate, any amendments, and adoption. *(Anticipated total time allowance for this segment of the program: 1 hour.)*

. . .and on Human Services Report

Also at the October meeting, delegates will hear from Evelyn Staples, Chairman of the Public Services Committee, who will present for consideration by the Federation her Committee's Resolution on the recently completed Report of the Arlington County Human Services Commission.

The Report is the culmination of a two-year review of the system of human services delivery in the County and includes recommendations for restructuring for increased "coordination, integration, focus and efficiency."

Note: Copies of both Committees' Resolutions will be available in the lobby of the Conference Center at 7:00 on the night of ACCF's meeting in order to provide delegates an opportunity to familiarize themselves with the recommendations before discussion periods.

(During this gala 80th Anniversary year of the Federation, we'll be looking back through our archives now and then to demonstrate that "the past is prologue.")

From Executive Committee Minutes, Jan. 1929:

... "Mr. Varney moved [that the Federation recommend] that it would be unwise for the Board of Supervisors to permit the location of any manufacturing plant or major industry in Arlington County until such time as the Zoning Commission shall have zoned the County in accordance with the act of the General Assembly."

... "Mr. Mann offered a resolution recommending that the County Jail be repaired and made sanitary."

... "Mr. McNemar moved [to offer a resolution to the Federation for adoption] that necessary appropriations be made by Congress for the purpose of policing military highways in Arlington County leading to Ft. Myer Heights and to the National Cemetery..."
