2) Crime in Arlington -- Statistics and Trends

Our Schools. Our Public Safety -- Two vital sectors of our community that provide the key to Arlington's future -- these are the two-pronged focus of the Federation's December 3 meeting.

First, we'll hear from the **County School Board**, who have been requested by the
Federation Schools Committee, chaired by Roye
Lowry, to address a number of questions relating
to **academic performance** in the schools, and to
the **Capital Improvement Program (CIP)**.

Because a disproportionate number of students whose academic performance is below the national norm as measured by standardized tests appear to come from Arlington's African-American, Hispanic or non-English native language communities, the Committee has requested that the School Board consider questions such as:

- How do they assess the effectiveness of current programs designed to improve the academic performance of these students?
- What goals have they established to measure degrees of improvement resulting from these programs?
- Are other efforts being planned to address this problem?
- Is there an overall, consistent plan?
- Is there a resource problem?

### Questions posed concerning the CIP include:

- What is the status of improvements to the CIP process?
- What is the official process for soliciting neighborhood civic association involvement in the planning process for schools within their boundaries?
- Will civic associations have opportunities for early input in the planning process?
- Will the joint use of school facilities be considered in the planning for all projects?
- Will the Parks and Recreation Department participate both administratively and financially in the planning and operation of joint-use facilities?
- How will we be able to compare facilities we get from our CIP investments with those we expected to get when we voted for school bonds?

## Delegates Adopt 1997 Legislative Package

At the Federation's November meeting, delegates hammered out a mammoth "wish list" of nearly 60 pieces of new or changed legislation. Most of the items in the package are directed toward state

legislation, but some of the items are directed toward federal or local laws. Many of the items are holdovers from previous years. New items passed in the '97 package include support for:

- Legislation to end the federal tax subsidy for professional sports facilities.
- Establishment of an Office of Inspector General for Arlington County to audit and review County performance in areas such as contracting, purchasing, land sales, and facility construction to assure appropriateness of expenditures.
- Repeal of the Virginia Stadium Authority.
- A referendum on the question of electing County Board members from single member districts with an at-large chairman and vice chairman.
- No increases in compensation for County Board

Copies of the 1997 Legislative Package as adopted will be available to delegates at the December meeting.
