Rules For Candidates Night

Floor rules

- 1. Each candidate on a panel will make a two minute opening statement. The order will be determined by a random drawing.
- 2. Federation Delegates and Alternates are invited to register to ask questions by completing a name card and placing the card in the appropriate box [located in the Lobby] for each panel. Delegates will be chosen by random drawing to ask their question. Delegates who have already asked a question of an earlier panel will not be eligible in the drawing for subsequent panels.
- 3. Questions to a candidate MUST be concise and NO more than thirty seconds in length. Statements of position, argumentative or derogatory comments, multi-part, and follow-up questions are forbidden.
- 4. Each candidate will then have one and a half minutes to answer each question posed to any member of the panel.
- 5. Signs, banners, and audio-visual presentations are not allowed in the Conference Center lobby, hallway, auditorium, or on the exterior of the Hospital buildings, or on the Hospital grounds. Literature may be distributed in the lobby ONLY.
- 6. ONLY authorized press and ACCF representatives may tape or photograph the proceedings.
- 7. Candidates and their supporters are expected to respect the Hospital's rules as well as the sensitivities of patients and visitors during the evening.

Arlington's Field House Project

During the summer, the Arlington County Board formed a Work Group to determine candidate sites and size for a Field House to accommodate the various Parks and Recreation Department (Parks & Rec) programs currently using the Gunston gymnasium. Gunston Middle School needs the gym back for student use or the school may lose state accreditation.

Because the Work Group was hurriedly formed during the summer months, when many of Arlington's civic associations are always dormant, the County was unable to adequately Auh formant,

ify affected residents, Civic Association members or the ACCF membership. This is extremely unfortunate as the Field House may have a major impact on the community in which it is located and is projected to cost County taxpayers between \$1.6 and \$3.2 million. The ACCF and other civic groups suggested that more community review was required.

From more than 20 sites, the Work Group identified four: Barcroft Park on Four Mile Run Drive; Gunston Middle School, sited on the current three school tennis courts and part of a soccer field; Virginia Highlands Park, sited on the two current basketball courts and part of a soccer field, and three properties in the 6000 block of Wilson Blvd., land the County is currently trying to purchase for parkland. The Work Group vote on these sites strongly favored Barcroft Park, eliminating the other three sites. As a second option, some also favored splitting the project, with the second part at the vacant site of Augi's Crabbby Pig taurant at Glebe Road and Old Glebe.

At the last Work Group meeting, the Staff Facilitator stated that Staff was meeting with the County Manager on August 22nd and that its position would be "slightly different" from

that of the citizen's Work Group, but that the report would not likely be available for public review until Monday August 25, the day of the Planning Commission hearing. It should also be noted that neither the Transportation nor Environment and Energy Commissions has as yet been included in the siting process.



Are Approved Phased Site Plans in Jeopardy?

You can learn first hand how the process begins when a developer presents a plan to convert the equivalent of about fourteen city blocks from residential to commercial. The proposal is for a strip mall. The location is the green space near Pentagon City.

Come to the Planning Commission's Long Range Planning Subcommittee meeting at 7 pm Tuesday, September 9. (Call the County Board Office at 358-3130, for the location.)

The developer, Federal Realty Investment Trust (FRIT) proposes that the County government overturn a 22 year old Phased Development Site Plan. The other phases built out to date have been built according to the Plan, but now the developer would prefer to build more retail space, with potential impacts on the adjacent neighborhoods. Could successful action by the developer jeopardize zoning, land use, and neighborhood integrity anywhere Phased Development Site Plans are used in the County? The issue merits your attention this fall.
