## School Board Program

The School Board will be our guest at the March meeting of the Federation. The Board will give opening remarks for 20 minutes. Following opening remarks, the Board will be asked questions submitted in advance by the Federation’s School’s committee. At the meeting the Schools Committee will be asking questions on a wide array of issues such as, pre-K population increase, cost per pupil in Arlington, transportation issues, computers in the classrooms and the problem of concentrating low income students in a few enlarged elementary schools.

After these prepared questions, the floor will be open for member delegate questions for the remainder of the program. This program will be 55 minutes in length.

Member delegates and alternates are reminded that their questions should be questions and that position statements are not questions. In addition, questions shall be thirty seconds in length. Finally, in the interest of fairness and an effort to make sure that all member delegates may ask a question, follow up questions will not be allowed.

## Candidates Night Arlington County Board Special Election

The second part of the March program will be a debate between the candidates for the County Board seat recently vacated requiring a Special Election on April 8, 2014. The debate is open to all candidates on the ballot and they are: Democrat Alan Howze, Independent John Vihstadt, Independent Green Janet Murphy and Independent Stephen Holbrook. The debate including opening and closing remarks and questions and answers will be approximately 40 minutes in duration.

## Noise Control Code

The Planning and Zoning (P&Z) Committee anticipates that a Request to Advertise the new Noise Control code language will be on the County Board's March agenda. P&Z hopes to meet with Staff one more time to ensure that we are correctly interpreting their revisions to the current Noise Control Code and to advocate for the items in the resolution that we presented after our report and the Staff presentation at the February 4<sup>th</sup> ACCF meeting.

We are emphasizing in our advocacy that the noise protections given only to "R" zoning districts be expanded to all "residential uses." Furthermore, the co-chairs are concerned that without such broadening that the entire provision could be subject to legal challenge under equal protection provisions of Virginia law.

## Zoning Ordinance Changes

Standby for an Arlington staff presentation projected at the April ACCF meeting on additions to the Zoning Code. Committee members have been attending ZOCO meetings and have prepared points relative to concerns for the ZOCO committee's consideration.

## Arlington Affordable Housing Study

Arlington County has been undertaking a study to understand better its housing needs and to reassess its housing principles, goals and targets. An 18-member citizen advisory group was appointed by the County Manager representing a diverse set of stakeholders with interests in housing issues. Kathryn Scruggs represents the Civic Federation on the Affordable Housing Study Working Group. After months of deliberating and seeking public input, the Working Group approved a new set of housing principles in January. These principles will eventually be considered by the County Board as part of the Affordable Housing Element of the County's Comprehensive Plan.

### What's next?

The County recently signed a contract with George Mason University to provide additional analysis to determine housing needs at varying income levels. As part of this process a survey of 1700 Arlington residents will be conducted in the spring. So, if you get a phone call asking for a few minutes of your time for the survey, please stay on the line. You will help the County understand better the housing needs in Arlington.
