# Potential Changes for Curbside Refuse and Recycling-Managing Solid Waste

Arlington County is planning changes in curbside refuse and recycling services starting next June and is seeking input from Civic Associations and residents. Proposals include adding yard waste and food waste to year round recycling or composting.

- What would food waste cover?
- What would you see as the primary barriers to recycling food waste?
- What methods would you prefer for collecting yard waste bags? carts?
- How would proposals affect fees?
- Are Civic Associations taking positions on options?

Erik Grabowsky, Arlington County's Solid Waste Bureau Chief, will provide an overview of the changes under consideration and will discuss the feedback they have received so far from residents through meetings and the online survey. ### Civic Federation to Feast on Urban Agriculture Report October Meeting

Whether to liberalize the current County ordinance governing backyard hens is just one of several fascinating and potentially controversial subjects to be aired at the Civic Federation's October 1 meeting.

John Vihstadt, appointed by the County Board to Chair Arlington's Urban Agriculture Task Force (UATF) in March 2012, will present an overview of the Task Force's report of nearly 100 pages. The report, produced entirely by the volunteer group and unveiled at a June County Board work session, represents a cornucopia of information and recommendations developed over a year of study, field trips, forums, and community outreach. The Task Force was charged "to research best practices in sustainable urban agriculture policies and make recommendations to support, expand and integrate existing urban agriculture efforts consistent with [Arlington's] community values and adopted Vision Statement [for]....a sustainable community..." ### Resolutions

Proposed Resolution: Establish an Independent Authority to Review the

## Arlington County Budget and Selected Programs and Projects

#### WHEREAS,

- The Arlington County budget has grown to over \$1 billion, and the County has inadequate internal budget controls and review processes;
- Fairfax and Montgomery Counties have established budget and program/project review mechanisms that have resulted in substantial savings;
- The County has recently witnessed significant cost overruns in conjunction with Artisphere operations and the Columbia Pike Super Stop construction;
- The ACCF previously approved as part of its annual budget recommendations for FY 2012 and FY 2013, the study, funding and establishment of an independent budget review authority; and
- The County's own auditors in their FY 2012 audit letter accompanying the report on the County's finances recommended that the County "Establish an Independent Internal Audit Function" and further stated, "Establishment of an internal auditing function could result in substantial benefits to the County in terms of strengthened internal control and increased efficiency."

#### THEREFORE BE IT RESOLVED

That the County fund a study by independent advisors for the purpose of establishing an independent County budget review authority that will provide Arlington County residents and taxpayers with reasonable assurance that their taxes and fees are being effectively and efficiently spent.

#### **MEALS ON WHEELS PROGRAM**

Unable to grocery shop for yourself or prepare your meals at home? For those unfamiliar with a longstanding community service, MEALS ON WHEELS of Arlington for over 40 years has been providing reliable delivery of two meals a day (M-F) to hundred of residents, regardless of age or income, usually homebound because of a long-term disability or a short term convalescence. Volunteer drivers gather at the 1st Presbyterian Church parking lot to receive the day's meals that are prepared at a commercial kitchen. Then, according to assigned routes which cover all sections of the county, they deliver between 11am and 1pm. Clients with sufficient income pay in full the \$28 per week. For those with limited means, MOW can arrange for a subsidy to offset the

cost. You or a neighbor you know may benefit from this service, even on a short-term basis. We also welcome new volunteers to drive or be a teammate to deliver the meals. ### Hens in Every Household (cont'd)?

While there has been a great deal of community clucking about the pros and cons of expanding opportunities for County residents to raise chickens and other livestock, the report yielded nine priority recommendations, including:

- Expanding the availability of community gardens and urban farms throughout the county;
- Strengthening the already-robust Arlington Farmers' Markets network by facilitating the use of food stamp benefits at all market locations and supporting the creation of a permanent covered year-round Farmers' Market;
- Encouraging the establishment of a local food hub, including an online option to match food producers, distributors and consumers;
- Considering urban agriculture education focusing on Arlington school children in any adaptive reuse or repurposing of the historic Reeves farmhouse at Bluemont Park;
- Initiating a municipal composting system;
- Performing a comprehensive review of all County planning documents to give priority to sustainable food planning and
- Establishing a standing Commission on Urban Agriculture, structured similarly to other County advisory commissions.

The UATF, composed of nearly 20 individuals representing a variety of interest groups and perspectives, also included Civic Federation delegate Darnell Carpenter. Several Task Force members are expected to attend the October discussion.
